


## RETIREE HANDBOOKS!

## COMMENTS FROM THE EDITOR

Preserved in the John F. Kennedy Library And Museum is a transcript of an interview between then Senator John F. Kennedy and Walter Cronkite, leading up to the 1960 Presidential Election. In it Cronkite closed-out the interview with this simple question: “Senator, one final question: What single quality do you think will be the most important that you take to the White House?” Kennedy replied: “Well, I think I’ve had – a historical view of the United States and of its relations through the world. I’ve been interested in it really since I was very young, and I think a sense of the past where we have been in this country, the relations in Europe, will be a great help in the future. I remember a story about many of the papers prepared by some talented young men at the Versailles Conference, on the future of Europe, were based on recommendations by Tallyrand at the end of the Napoleonic Wars at the meeting at Vienna. I think that Lincoln said, ‘Until you know where you have been, you don’t know where you are going.’ And that’s the way I feel. I think a, of course, a sense of responsibility, and a sense of great interest in our country, and also a sense of the historical past here and through the world, I think are very valuable for the future.”<sup>1</sup>

You’re probably wondering, what does this have to do with the Association of Former New Jersey State Troopers? Well, it doesn’t have anything to do with politics, and I’m not polling anyone to see you liked Kennedy, or not. It has to do with his answer to Cronkite’s question. Kennedy, like countless others have credited Abraham Lincoln as saying many profound quotes, including this one, “Until you know where you have been, you don’t know where you are going.” I’ve looked, and the closest quote attributed to Lincoln is, “If we could first know where we are, and whither we are tending, we could then better judge what to do, and how to do it. While Kennedy may have only been paraphrasing Lincoln, his answer can and quite possibly, should be applied to most people and most organizations. Does your history lead to where you are going, your future?

The April issue of this newsletter led off with an overview of the founding of our Association. The initial review of our founding documents was what Kennedy was talking about, how his learning of history through papers prepared, documenting events through the ages, gave him an insight into the present, and quite possibly the future. That premise has now led to the formal documentation of our past, via the digital archiving of our historical papers. Unfortunately, our research has revealed many gaps in our historical record. As such, as Chairman of the Administration Committee, I respectfully request anyone who has copies of past Meeting Minutes, Newsletters, and any other relevant documentation surrounding our Association to please call or email our Office. If you possess copies of records we’re missing, we will gladly make arrangements to have them copied and returned to you. With your help, I am confident we can fill in those gaps and complete the continuing historical record of our “Outfit,” via the Association of Former New Jersey State Troopers. Thank you.

As you well know, I continue to keep in contact with our own ‘Marathon Man,’ and 2016 recipient of the FTA Former Trooper of the Year Award, Lt. John Ouweleen, #1759 (*Ret*), here’s the latest updates from John:

April 30, 2018: President Franklin D. Roosevelt declared that December 7, 1941 was, "A date that will live in infamy." Well my FTA members, April 16, 2018 rivals that description, however under different circumstances. Toed the line at 10:50am, in the village of Hopkington, MA for the start of the 2018/122nd running of the Boston Marathon. Temperature 37 degrees, squally rain with downpours, and 24 miles per hour winds from the east (In your face), gusting to 30-40 mph. AWAY WE GO!!! Four hours, 13 minutes and 36 seconds (4:13:36) later, I crossed the finish line in Boston, earning a second place, silver award, and a return to the World Stage for my efforts.

There is nothing further that I can say about the race, except that it was total endurance. What does the future bring? The 2018 Boston Marathon was probably my final attempt at the iconic race. Having competed eleven times, I am proud to claim the following age group podium finishes: One 1<sup>st</sup>, three 2<sup>nd</sup>, and two 3<sup>rd</sup>, along with that 5 other finishes ranging from 4<sup>th</sup> thru 10<sup>th</sup>. Notable, having finished in the top 10 in all eleven races.

So, now it is time to move on. There are many World Class Races that are being conducted in the spring of the year that I have eluded in favor of the iconic Boston.

Think Paris, France - April 14, 2019????

June 26, 2018: Things appear to be changing! In my April 30<sup>th</sup> report, I eluded to 2018 being my last Boston, and would be looking forward to new challenges, particularly Paris. Well, entry procedures have not gone well, and one glaring issue that stands out, is that it is a race that I cannot win my age group. To explain, Paris does not portray the usual age groups, ie: (40-44) - (45-49) - (50-54) - etc. Paris employs, Veterans 1, 2, 3 and Seniors (Which are elites). The age groups are 10 years apart. In my case, at age 78, it might even be more.

By virtue of my 2<sup>nd</sup> place finish at the 2018 Boston, I will be receiving as an award of a complimentary entry (Worth \$185,00) into the 2019 Boston Marathon. The offer will be

made approximately mid-August. I'm going to exercise my privilege and accept the offer, and at any time I desire to change my mind, I can decline.

Now, this is what I have done this month. I have not scheduled a race until the Space Coast Half Marathon, planned for November 25, 2018. I searched around for a quality race for the early fall, to serve as a tune-up for Space Coast. I discovered a BIG, VERY BIG race, that I have registered for. Thru USATF (USA Track and Field) I was introduced to WMA (World Masters Athletics). At this point, I was completely oblivious of WMA. I learned that the IAAF (International Association of Athletics Federations) is the governing body for sports and athletics, and has commissioned WMA to conduct a bi-annual Masters (Age 35 and above) World Championship Marathon. It appears that this has been going on for several years, and on each occasion, it appears in a different part of the world. This year, 2018, the race will be conducted on October 21<sup>st</sup>, and it will be presented in conjunction with the Canadian National Championship in Toronto, Canada. The race is titled, "Scotia Bank Waterfront Toronto Marathon," and will reflect an Olympic style atmosphere. AND, I AM IN!!!! This will be an exciting challenge that will bring the world's best Masters' to the world stage. I am certainly looking forward to compete, and as always, represent.

So that's the update. The number one thing is that I am healthy, ready to compete, and represent the good old New Jersey State Police/Former Troopers Association.

Congratulations John and best of luck in October at the Scotia Bank Waterfront Toronto Marathon, and in November at the Space Coast Half Marathon. We'll be rooting for you, every step of the way!

In closing, I'd like to bring your attention to the plight of a fellow Jersey Trooper and his family who are in need of some very special help. Sergeant First Class Daniel J. White, #4256 (*Ret*) and his two older brothers, Bobby - a former Highlands Police Officer and Richard are now in end stage renal failure, all suffering from Polycystic Kidney Disease (PKD). Bobby and Richard have been on dialysis for a couple years, and time is growing short for Dan.

PKD runs in families. It's an inherited disorder that is passed from parents to children through their genes. Dan's father died at sixty-three from kidney failure. The disease has hit everyone in their family for several generations. Unfortunately, their kidneys are failing at a younger and younger rate. Dan's two sons (25 and 27) both have PKD.

Dan retired seven years ago after serving for 25-years in the Outfit. He knew what the future would bring, and he wanted to be able to enjoy life as much as possible before the inevitable came along. At only fifty-four years young, time is running out. Without a donor, Dan will be forced to begin dialysis while waiting for a kidney to be donated.

Dan and his brothers are registered at Saint Barnabus Hospital in Livingston, NJ. Dan's girlfriend, Felicia Cooper has volunteered to be the family's initial point of contact for potential donors, so as not to overwhelm the hospital. Dunny got us all together before we took the field and said, "Guys, you know what they said they were going to do to us tonight, because we are Troopers, so let's get 'em." I was running the ball back on a kickoff and was flattened by two of the other team's guys. This was supposed to have been rough touch, not tackle. Dunny saw that they were attempting to intimidate us, and he wouldn't have any parts of it. He was phenomenal that night. He did it all and we won the game. Guys from the other team wanted to know who the red headed kid was that ran around like a crazy man. They just didn't come any tougher than Dunny.

Dunny and I began to go out socially and talking about our families. I learned that while he was born in Camden City, New Jersey on March 8, 1947, he grew up in Hershey, Pennsylvania and went to the Milton Hershey School in Hershey, Pennsylvania. The Milton Hershey School is a private boarding school in Hershey, Pennsylvania, originally established for impoverished, healthy, male orphans, while today it serves students of various backgrounds. After graduating from high school in 1965, Bob joined the United States Army and became a member of the 101<sup>st</sup> Airborne Division, the "Screaming Eagles." He served in Vietnam where he was severely wounded in the head by an enemy hand grenade in 1967. That same day, six other members of his company were killed during this battle. Bob received the Purple Heart and the Combat Infantry Badge. Bob recovered from his injuries and completed a three-year hitch in the Army. Bob has a brother and a stepsister. His brother was in Vietnam at the same time Dunny was and he too, was wounded and survived.

Bob, Tom McCreight, #1942 and I went to Camden County College and Stockton State College under the GI Bill together and graduated in 1976. All of us received our Bachelor's Degree. Dunny went on to get his Master's Degree at Seton Hall University.

We left Woodstown and met up again while stationed on the New Jersey Turnpike at the Moorestown Station. We both belonged to Jim Corea's Gym in Cherry Hill, New Jersey, along with about another 100 Troopers.

It didn't take Dunny very long to go into plainclothes, because he was so talented in solving crimes. He went on to the Major Crimes Unit at Division and established himself as an outstanding detective. After Dunny was there for a while, Warren Ferry, #1806, who Dunny and I respect immensely, was also assigned to Major Crimes. He and Warren became great friends and solved many cases together. Warren told me that he learned a lot from Bob, and Bob was the best detective he ever came across.

Dunny and I went out one night for dinner and we began to talk about Vietnam. I recall Dunny lying down on a bench at Jim Corea's Gym, because he had such horrendous painful headaches. Sometimes, he would lie there for an hour or two before these headaches would subside. He told me the headaches were from his injury he received while in Vietnam. Dunny was involved in many operations in Vietnam whereby a lot of killing occurred. One of the worst stories he told me, involved many enemies, many 101<sup>st</sup> Airborne guys, and many civilians were killed. As he was telling me this story, he began to weep and told me that this was the first time he told anyone this story.


Sometime in 1977 or 1978, Bob's lease was up on his apartment where he was living, and he didn't want to renew the lease. He was looking for an apartment but couldn't find one that he liked. He had to get out of the apartment right away or sign another lease for a year. As I was recently divorced and having primary custody of my 9-year-old daughter, Cindy, with plenty of room at our house, I invited Bob to come live with us until he found an apartment. My daughter knew Bob previously and just loved him. Little did she know that Bob would cook healthy meals with plenty of vegetables. She hated vegetables and wouldn't eat them for anyone until Bob came along. Our first meal had steaming vegetables and my daughter, Cindy, would not look at them. Bob looked at her, smiled and told Cindy to eat her vegetables. She looked at Bob and said in a low voice, "Yes sir, Mr. Dunlop." She ate all of them. She told me later in life when Mr. Dunlop told her to eat the vegetables he said it in such a way she didn't want to disappoint him by not eating the vegetables. Bob lived with us for about four months before he moved to Jim Corea's football camp in Medford, New Jersey. He lived in the house on the site of the football camp and was the overseer of the football camp for many years. He and Bobby Clarke of the Philadelphia Flyers, and a few other guys eventually purchased the football camp from Jim Corea. They sold the property years later.

I retired in 1986 and started a private investigation business. After Bob retired from the State Police, he called me and told me he was going to get his Private Investigator License and start a business. He asked me if I would help him get started in the business. After he got his license, we met and put his brochure together and we talked about how he was going to get business. I told him while he was trying to get business I could use him because I was getting busy. We started working together again.

Once, while we were performing a surveillance together during a very cold February, Bob told me he was going to get a heater for his van because he didn't want to leave his van running for heat. The next day he was in his van and I was in my van and we had two-way radios. I told him as soon as this guy comes out and leaves in his vehicle, call me and then he could fall in behind the guy's vehicle. Bob called a while later and said okay he just left, he's coming toward you I will be behind him. This guy's vehicle came by me and I'm waiting for Bob's vehicle which is not behind our guy's vehicle. Dunny came over the radio and said my battery is dead from running the heater. I asked him if he started his van periodically, so the battery would not run down. Bob said, no, I forgot. I said, "hey recruit, what's wrong with you." We had a big laugh, but Bob apologized 100 times. I told Bob that things happen, forget it, we will get him another time, and we did. After working together for a while Bob went to work for Commerce Bank which was subsequently purchased by TD Bank. Bob was the Director of Security and Investigations. Bob hired a lot of retired Troopers. He remained with TD Bank for approximately 10-years and retired. As part of his retirement, he and his family moved to Boise, Idaho, where they are currently living. It was Dunny's intent to enjoy many years of a fruitful retirement.

One day about two years before Dunny left TD Bank we were talking, and I noticed that Bob was starting to stutter some of his words. I noticed this several other times when we talked. I asked Bob if he noticed that he was beginning to stutter. He told me he hadn't noticed he was stuttering. He would also say over and over, "Okay let's see, let me get this straight," and he would stutter even more. I suggested that the next time he went for a check-up to ask his doctor about the stuttering. He said he would. Little did I know at that time that this was the start of a disease called

Primary Progressive Aphasia (PPA). PPA is a neurological disease in which language capabilities become slowly and progressively impaired. It was explained to me in layman's term as a disconnect between the brain and his speech. His troubles were just beginning.

It was shortly thereafter that Bob, his wife Mary, daughter Amy, and their son Mark, moved to Boise, Idaho. Amy is currently an EMT and is pursuing training to qualify as a Paramedic. Mark is their special needs son, to whom Bob and Mary are very devoted. Their son Matt lives in Winslow, New Jersey, and is a Camden County Police Detective in the City of Camden, New Jersey. I knew Mary from my old neighborhood in Barrington, New Jersey, and introduced her to Bob sometime in the eighties, and the rest is history.

Bob has deteriorated rapidly since moving to Idaho. He now has full blown Alzheimer's in addition to the PPA. He has had bladder cancer and prostate problems. He no longer can drive a car, ride a bike and has a hard time with his balance. He stills walks, but not very well. Everyone has hoped he would remain in his home with his wife Mary as his fulltime caregiver. She has done an outstanding job, but it has taken a toll on her. Their son Mark is a special guy from birth and Mary also cares for him.

Mary has allowed me to read all of Bob's medical records on his diseases. All the evidence and doctors' medical reports indicate Agent Orange, the chemical used to kill foliage in Vietnam, and his head injury as the culprits. So far, the Veterans Administration has given Dunny 30% disability. What a joke, he should be 100% disabled. I have dealt with the VA for many years on my own issues from Agent Orange and have learned a lot. I have tried to guide Mary with the VA, and my VA representative from New Jersey is now representing Bob and Mary on his appeals for his claims.

I used to talk with Dunny several times a month after they moved to Idaho, but now I talk at him. He doesn't talk much. I try my best to get him laughing, but that's getting harder to do. When we talk, I must lead and guide our conversation. I learned to do this over time by talking with him. You hear him saying the same few words over and over and you just agree with him. I recall some of our memories while we were Troopers and he always responds with a laugh or responds, "oh, yes." I believe Dunny still knows who I am, but I'm not 100% sure. I will call him and say you know who this is, and he will say you know who you are, that kind of thing. My heart breaks for Bob and his family. Mary just recently told me that Bob had an appointment with his neurologist and the neurologist told her there was no need to return as there is nothing else he or anyone can do for Bob. As of July 17, 2018, Mary had to move Bob to a nursing home near Boise. Bob started having flashbacks about Vietnam and is becoming somewhat violent and out of control.

## HISTORICAL HIGHLIGHTS



**Tuckerton Station, circa late 1930s - early 1940s**

From time to time, historic renderings come to light, offering a glimpse of our State Police past. A look back if you will, to a time when State Police uniforms were actually made of thick wool, britches & boots were the ‘uniform-of-the-day,’ and of course, there was no air conditioning in the troop cars! And if that wasn’t bad enough, in the sleepy hollow of Tuckerton, New Jersey – greenhead flies were much bigger than they are today, and much more deadly!

All kidding aside, the captioned photo is of the Tuckerton Station with its compliment of men and machines during that time-period. The picture and a copy of an accompanying 1971 Special Report authored by then SSG C. Kalwaitis, #1035 at Tuckerton was furnished for reprint by now Sergeant First Class Carl J. Kalwaitis, #1035 (*Ret.*).

The Special Report was addressed to Captain J.A. Carpani, Commanding Troop “A” NJSP, Hammonton, N.J., and was titled: History of the Tuckerton Station. It reads as follows:

1. In 1927, the original Tuckerton Station was opened in a large beautiful home on US #9, where St. Theresa Catholic Church is now situated. This home was owned by the Selize family, who were related to the Stetson Hat Company family.
2. The Station consisted of two bedrooms, a telephone, two Troopers, 1 horse, 1 motor cycle.
3. Retired Trooper Paul B. Hughes, 8<sup>th</sup> Class, Badge #258, relates that he was a recruit stationed at Tuckerton. He was detailed to a parade in Salem, N.J., commemorating their 200<sup>th</sup> anniversary. He was given a week to report there on horseback. Enroute he stopped at Hammonton Headquarters two days later and was advised the detail was cancelled.

4. Absecon Station had the only Troop Car in the area at that time. If a prisoner had to be committed to the county jail, or some other detail arose requiring a Troop Car, arrangements were made to borrow their car. Usually their car would be in Cape May Court House, so a civilian car had to be borrowed for these details.
5. On July 1, 1934, the Tuckerton Station was closed due to a decided decrease in appropriations.
6. Later, Stations were temporarily in Barnegat and Chatsworth.
7. Urgent appeals had been made by many Tuckerton residents and nearby communities in an effort to reopen the Tuckerton Station.
8. The Tuckerton Borough Council issued a resolution urging the reopening of the Tuckerton Station. In January 1937 State Senator James Allardice, Secretary of State Thomas Mathis, and Mayor Parker had a conference with Colonel Kimberling of the New Jersey State Police for the purpose of presenting a plea for the reopening of the Tuckerton Station. Two previous efforts were unsuccessful.
9. On July 12, 1938 at 11:20 a.m., the Tuckerton Station was reopened at its present location by Cpl. J.C. Smith, Troopers Torrell, Austin, and Aydelotte.
10. Originally, Dr. Lane had a doctors office and resident in a portion of the Station in which he owned.
11. Several years later the Station was sold to Mr. Monroe Lustbader, who is the present owner of the Station.
12. On March 7, 1962 a severe storm struck the Tuckerton area. Troop "A" Commander, Captain G. Martin was in charge of a detail of approximately 75 Troopers who were billeted in the Tuckerton Armory, where the Command Post was located. The main part of this detail lasted two weeks, and it was eventually phased out two months later.
13. A checkpoint was set up on the Manahawkin Causeway for approximately two weeks. The checkpoint was then moved to Surf City, then subsequently to the entrance to Harvey Cedars, where this part of Long Beach Island was completely isolated by the ocean from the main part of the island. The checkpoint remained at this location for approximately six weeks, until the detail was phased out.
14. In addition, patrols were set up on the island for vacation purposes and to prevent looting. A detail of Troopers were flown into Barnegat Light due to the isolation of the northern part of the island.
15. Coast Guard helicopters were utilized to evacuate the island residents whose homes were washed away or destroyed. Emergency housing was provided at the Manahawkin schools for these victims.
16. In cooperation with the Bureau of Navigation, patrols were established in the bay from Barnegat Light to Beach Haven to protect property from looters using the waterway.
17. While this storm was in progress, Long Beach Twp. Police Chief Leonetti and two rescue workers were riding in a jeep, and were washed away by the ocean tide and drowned.
18. In another incident, two men and two women were being evacuated in an amphibious duct when the vehicle capsized and they drowned.
19. In December 1970, construction began on the site of the new Tuckerton Station, which is located four miles north of the present Station, on US #9, Eagleswood Twp., Ocean County, N.J. Completion of the new Station is anticipated in the Spring of 1971.

Initial attempts to identify the four uniformed Troopers in the picture were met with negative results. They may very well be Corporal John C. Smith, #313; Trooper Nicholas A. Torrell, #449; Trooper Fred Austin, #315; or Trooper Stanley H. Austin, #455; and Trooper Arthur B. Aydelotte, #548, as noted in the Special Report. If you happen to know, call the FTA Office and identify them for prosperity!

## **BARBARA BUSH'S LAST MOMENT WITH FORMER SECRET SERVICE AGENT 'DEFINED' HER AS A PERSON**

The last time former Secret Service agent Jonathan Wackrow worked with former first lady Barbara Bush, she made a request that left a lasting impression on him.

Wackrow explained in a CNN op-ed that he wasn't assigned permanently to her detail but worked with her on multiple occasions.

After the Bush family left the White House, he was charged with driving her from New York City to New Jersey.

He recalled that the motorcade only consisted of a couple of Secret Service vehicles and an unmarked New York police vehicle, but the "small and unassuming" traits were ones she appreciated.

However, when the motorcade exited the Holland Tunnel and crossed into New Jersey, multiple New Jersey State Police vehicles and motorcycles joined it, all of which had their sirens and lights going.

Wackrow wrote that the hubbub was one Bush tended to reject, but at the moment, a smile illuminated her face, and she told her staff, "They remember me! We have not had this much excitement since the White House!"

On their way back to New York, the former first lady asked the head of her security detail if they could stop so she could thank the police officers who "so warmly welcomed me to New Jersey."

The simple request left a lasting impression on Wackrow, who explained:

*Peering out the limo's back windshield, I will never forget the image of Mrs. Bush shaking hands with the officers. It was a genuine moment of sincerity and unguarded kindness delivered out of the public eye, which, to me, defined this great woman.*

The former Secret Service agent added that Bush's code name was "tranquility," which was fitting because of her "calming, humanizing and gentle effect on those around her."

Bush passed away at the age of 92 on Tuesday, and on Saturday, family and friends will gather in Houston to pay their respects and lay the former first lady to rest.

Though you may have changed it in your will, the beneficiary listed with Pensions and benefits, will be the person to receive your life insurance and pension (if applicable). This can be done through Pensions and Benefits, or directly through your Members Benefits Online System (MBOS) account.

Speaking of MBOS, if you don't already have an account, I strongly suggest that one be set up. You can have quick and easy access to all of your pension and health benefits information, as well as the ability to request info and make changes to your beneficiary and address. Instructions can be found here:

Though we all would like to think that we will live forever, we should provide all the relevant death benefit information to our loved ones, where to find all important documents and whom to contact. The following link will give detailed information on SPRS Death Benefits for Members:

This link provides information on your life insurance benefit, which is equal to 50% of your final year of salary. This benefit will be provided to the person who is listed as the beneficiary on your policy, NOT what is listed in your will. It's a good idea to print the Certificate of Insurance and keep it with your important documents. Visit: <https://nj.gov/treasury/pensionsdocuments/forms/life-sprs.pdf>.

The 2018 rates for health benefits can be found through this link for those surviving spouses who must pay in order to continue with their current coverage under the retiree. One plan, NJ Direct 10 will cost the surviving spouse \$522.43. Other plan information is listed as well. Copy and paste into your web browser:

Dental plan costs are not provided as part of the retiree package and must be paid monthly for both the retiree, spouse and dependents (if applicable). The rates for the different plans can be found here:

Medicare Reminder - ALL retirees and their spouse must register for Medicare upon turning 65. It is recommended that you contact your local Social Security office approximately 3 months prior to turning 65 to register. This can also be done online, if you prefer. Failure to not register and notify Pensions and Benefits could result in the loss of your health care coverage with the State. ## **ASSOCIATION OF FORMER NEW JERSEY STATE TROOPERS** **EDUCATIONAL FUND SCHOLARSHIP PROGRAM**

The Association of the Former New Jersey State Troopers Educational Fund, Inc. has been committed to provide educational scholarship opportunities and interest free loans to eligible State Police family members for several decades. The scholarship program will continue to offer scholarships to any child or grandchild of a New Jersey State Trooper (Active/Retired), who is living or deceased as set-forth in its By-Laws. The program consists of (3) annual scholarships being awarded, each in the amount of \$1,500.00. The scholarship is open to any student presently attending a college and maintaining a GPA of at least 2.5, and to any high school senior with an equivalent grade who plans to enroll in a state accredited college or university, anywhere in the USA. 
