A NEW WELCOME

We can all remember the original entrance to Division Headquarters on State Police Drive, as we drove up the hill flanked by well kept homes. And then in the early 1990s, in association with the opening of the State Police Museum and Learning Center, and the construction of Wilburtha Station, came a new entrance, one that eliminated the constant strain of troopcar traffic on an otherwise quiet tree-lined residential street.

In grand fanfare, the new entrance opened, sporting an openness of rolling grass fields, illuminated by a modern Blue and Gold sign trimmed in buffed aluminum. Separated by a well lit landscaped medium, this new driveway paved the way in and out of Division Headquarters and Wilburtha Station. In time, as security measurers dictated, a guard shack was installed to monitor the comings and goings of visitors, not specifically assigned to Division. In all, it offered a bold new perspective to those arriving at State Police Headquarters.



Over the years maintenance on the entryway waned, and at times it looked a bit haggard. Well, all that has change.

Last fall the main entrance was temporary closed for renovation. This renovation however, will not only spruce up the area, but beneath the grade, new and up-to-date utilities have been installed to service the ever increasing technology that our SP Force requires to keep in step with the criminal element we're sworn to pursue. Wilburtha Station is also being renovated and will be turned into a welcome center where all visitors arriving at Division Headquarters will be greeted. The new welcome center will house Recruiting and several other State Police support offices. PRESIDENT'S CORNER

First of all, I hope everyone's in good health and finally getting over the abusive winter we have had if you are still living up North.

For you Floridian's, I am envy of your weather. My wife Susan and I attended the Florida Winter Party on March 4th and 5th in Melbourne, Florida. It was a great event and a good time was had by all. There were about 90 people who attended. Besides me other officers and Directors who attended were; Terry Hennessy, our Treasurer and Directors Ken Wondrack, George Wren and John O'Keefe. Also speaking at this event was our new benefits administrator, Bessie Jones and she did a great job. After this event my wife and I visited my son in Pompano Beach and then we took the long ride to check out Key West, Florida. Boy it's a long ride and when we left it took us almost 9 hours to cross into Georgia.

I would like to give you a chronological list of the facts in our fight to get our cost of living adjustment (COLA) back, so you can see what the FTA has been doing in order to succeed in this matter. (This information was given out at the Florida Party).

June 28, 2011 - Revised pension law (Chapter 78) passed and signed into law on June 28, 2011 by Governor Christi. (Changes COLA benefit)

August 2011 - We had a meeting with Senator Sweeney, Senate President at his office. He stated we will get the COLA because we are funded to about 73%. Myself, then President Bill Yodice & Past President Sam Cunningham, (God bless his soul) attended the meeting.

September 2011 - There was a meeting between Senator Sweeney and local police and fire retirees. He stated they too will continue to get the COLA because they are funded at 76%.

February 2012 - We and all other pensioners received a partial COLA based on the law being signed in the middle of 2011. (2013 & 2014 no COLA was given).

February 2012 - Senator Sweeney realizes he made a mistake. (In fairness to Senator Sweeney, he apparently did not know how the COLA is adjusted under the new law).

May 2012 - Case was taken before Judge Hurd of the Mercer County Superior Court. Judge Hurd was asked to recuse himself because he is not a tenured judge. He refused to recuse himself and ruled in the States favor and stated the COLA does not have to be paid to retirees.

June 2012 - Case was appealed to the Appellate Court on the grounds that Judge Hurd failed to recuse himself and also that the COLA is part of the pension and should not have taken from the retirees.

January 28, 2014 - Case was heard by the Appellate 3 Judge panel. I was there and it looks like we won as far as I am concerned. Five lawyers represented for 4 of the 5 pension funds and 2 lawyers represented the AG's office. Precedent cases show COLA is part of the pension since 1958 and should not have been taken from retirees. The Appellate Court will make a ruling between 60 and 90 days. The State may appeal to the State Supreme Court or send back to the Superior Court.

February 18, 2014 - I met with the Governor's Chief Counsel, Mr. Chris Porrino at the State House. We discussed the COLA issue and the disparity between pensioners that paid into social security and those who did not. Local police & fire, and Troopers don't pay into social security, and the offset penalty on social security that most Troopers are saddled with, due to the offset law of 1985. (State saves on SS payments for police & fire and

Troopers). Also discussed a change in the COLA law (if we lose in the Appellate Court) to start COLA after 10 years of retirement or age 65 or both for all workers in the State retirement pension fund.

If the Appellate cased goes against us, we will meet with Senator Sweeney to discuss changes in the law.

February 26, 2014 - I attended a meeting of numerous retired law enforcement police & fire associations in Kenilworth, NJ. It was brought out by a Mr. Fox, one of the attorneys in the COLA case on Jan. 28th, that the court could rule in our favor but leave out the retirees that did not get a COLA prior to the new pension law which was signed on June 28, 2011; or in other words if you retired before Jan. 1, 2009 and received a COLA in Feb. 2011 you would be OK, but if you retired after Jan. 1 2009 you might not get the COLA. His opinion if the court rules for us on the whole COLA issue excluding recent retirees. Also there will probably be more changes in the pension law in the future to stop the amount of payments going out which is larger than payments coming in. (Ex-police & fire and Troopers working longer or to age 55 before being eligible for retirement, eliminating the 20 year retirement and more co-pays for active members).

I hope this information explains what has been going on with the COLA issue. We now have to wait for the Appellate Court to make its ruling before we go on to the next step of having new legislation drawn up. I will put any new information on this issue on our website bulletin board when it occurs.

HISTORICAL HIGHLIGHTS

GILLEN LIVES ON THROUGH HIS CLIPPING COLLECTION

Daughter finds scrapbooks in attic after 40 years

Newtown — When 93-year-old Muriel Campbell Gillen passed away on Oct. 13, 2012, she left behind many papers for her three daughters to sort out. Those papers included scrapbooks from their father, Terrence A. Gillen, who passed away on March 19, 1980. Gillen had served as a detective with the New Jersey State Police for 24 years with his assignments in the Sussex-Warren County area.

San Francisco resident Marion Gillen was surprised to discover among the papers two leather scrapbooks in which their father had carefully saved newspaper clippings about state police activities that included weddings of the officers in cases in which they had been actively involved. According to Gillen, the scrapbooks had been in the attic for more than 40 years as their father discontinued saving the articles after her sister was born.

"We knew that he cut out newspaper articles that had anything to do with family or friends but we never realize the extent of his clippings or about the state police articles," Gillen said.

To share the clippings, Gillen plans to scan them all into a computer and then save them on CDs so that each of the sisters as well as cousins may have a copy. Gillen intends to have a CD made up for the state police as well in the event that they too would like a copy for their museum in Trenton.

Unfortunately the bulk of the clippings are undated but they are guessed to be primarily from the 1940s. A perusal of the articles provides a panoramic view of the services provided by the state police during that period that presumably coincides with World War II.

Born in Paterson, Terrence A. Gillen was the oldest of 11 children. The family was poor but he was determined to make something of himself. He tried for two years to become a state police officer. In the interim he became a police officer in Radburn (New Jersey's first planned community that is part of Fair Lawn).

Following Gillen's acceptance as a state trooper, Gillen was assigned to Newton. One of the earlier articles saved by Gillen was about how the New Jersey State Police was being expanded for the first time in 13 years due to wartime demands and that a class of 86 recruits was being given intensive instructions and was expected to graduate in April. Marion Gillen wonders if perhaps her father was included in this specific class of recruits.

The cases to which the state police were involved were diversified and were greatly varied. As an example, one of the headlines read, "Two charged with stealing cows" while another reported on stolen turkeys.

Other newspaper clippings in which state police officers were involved in investigating ranged from runaway boys, car accidents, thefts, fires, suicides and drowning victims. Would you believe it? State police officers also were involved in investigating bigamy allegations.

Another investigation by state police officers involved a barn fire in which 56 cows were killed. Yet another headline read: "Two Army Deserters Arrested." Another newspaper clipping reported that "Two teenage girls called police as two German POWs had taken an Army jeep from Fort Dix and surrendered themselves at the Walker home in Branchville after the Jeep broke down.

Another news article reported that "Some human bones had been found in Walpack on the Flatbrookville Road near Millbrook. The remains were guessed to have belonged to someone about 30 years old. "Yet another article reported that a Johnsonberg man was arrested and charged with hiring two men to kill his wife.

Conspicuous by their absence was any reference to legal still raids. This type of raid was plentiful in Sussex County over the years, especially in abandoned barns but none appear in Gillen's scrapbook.

One tragedy that was reported involved former Newton resident Trooper Cornelius (Dick) O'Donnell who was fatally wounded by a murder suspect in Phillipsburg. His partner, Fred C. Perry, died two days later of his injuries acquired in that same confrontation.

Several airplane crashes are included among the newspaper clippings with most of them listing Detective Terrance Gillen as among those involved in investigating the crash and all involved Army planes.

One airplane crash reported bore a dateline of Oct. 23, 1944. In that crash, it was reported that "Two Army Officers Escape in Plane Crash - Third Officer Killed When Army Cargo Ship Drops



on Current farm, Andover Township." It was reported that "one was killed and two hurt when an Army Aircraft C-78 cargo and transport plane crashed on the Charles Current farm in Andover Township Saturday night." Later in the article it was noted that "the survivors told authorities they were forced to land, having gotten off their course in the storm and their gasoline supply having given out."

One plane accident happened on June 17, 1947, when a medium bomber, supposedly hit by lightning, was blown to pieces by an explosion. Six men were blown to bits in the accident that occurred on the Regino Farm in Hampton Township on the road leading from Swartswood to Myrtle Grove, about 1½ miles from Swartswood.

A newspaper clipping dated Aug. 26, 1948, reported, "Nine Die in Crash of C-47 on E.H. Blakeslee Farm - Worst Plane Accident in History of Sussex County." This newspaper article commenced with "the worst plane accident in the history of Sussex County occurred on the E.H. Blakeslee Farm at 1:10 p.m. on Monday, when a C-47 Army transport crashed and burned killing nine men.

Later in the article it explained the probable cause of the accident by advising that "shortly before the crash the transport and a B-25 bomber scraped each other at an altitude of 7,000 feet. Lt. David F. Tatum, pilot of the bomber, radioed Mitchell Field, L.I. that he had scraped against a C-47. The bomber continued to Stewart Field, Newburgh, N.Y., where the plane landed safely. The crew stated they were flying at cloud level when suddenly a plane seemed to loom out of the clouds. The B-25 veered sharply and they felt a slight jolt. Then they noticed the damaged left wing and returned to Stewart Field. No one of the crew of the bomber was hurt..."

Time passed by. Marion Gillen guesses that her dad's scrapbooks that he so carefully maintained years ago have been in the attic of their former home for about 40 years. But, now that they have been brought to light they help to provide insight on the daily and varied activities of the state police during the 1940s.

The above article was written by Jennie Sweetman and published in the New Jersey Sunday Herald on August 18, 2013. Ms. Sweetman was only too gracious to permit this reprint for your information and personal enjoyment. A clipping of the article was sent to me by SFC Frederick M. THE ELUSIVE MEDAL



The *True Blue & Gold* (TBG) newsletter is pleased to continue with our interviews of combat veteran members of our State Police Family. The following is an interview of Major (*Ret.*) George T. Coyle, #1528 (GTC), regarding his service in the United States Marine Corps during the Korean War.

TBG – Major, when did you enlist in the Marine Corps?

GTC- I graduated from St. Mary's High School, South Amboy, NJ in June 1952, and enlisted in the Marine Corps the following September.

TBG – When did you go to Korea?

GTC – I landed at Inchon on 5 April 1953 as a member of the 31st Replacement Draft to Korea and was assigned to "D" Company, 2nd Battalion, 1st Marines, 1st Marine Division. It was Easter Sunday, and my unit was holding positions on the Main Line of Resistance (MLR) in the area near Panmunjom, Korea. I moved up on the "Line" and reported for duty with "Dog" Company. I was nineteen years old.

TBG – How long were you on the MLR?

GTC – We stayed on the line for a month. On 5 May 1953, the entire 1st Marine Division was moved into a reserve area on stand-by, in the event we were needed to reinforce other units.

TBG – What was your particular position in D Company?

GTC – I was an infantryman, or, as the popular title says, I was a "Grunt." I carried the Browning Automatic Rifle (BAR). Since I was a recent arrival, together with other personnel I was assigned to what was referred to as a "clutch platoon." This was a platoon of Marines drawn from many different units, which was moved up behind the lines to serve as a ready backup for units in the event of an attack by the Chinese Communist Forces (CCF).

TBG – How long did you serve with the clutch platoon?

GTC – Through May and June of 1953 we served in that capacity. Our duties were unit training as well as stand-by assignment along the Panmunjon Corridor. This was a designated road from the MLR to the site of the truce talks in Panmunjon. Our stand-by assignment was to be in close proximity in the event we were needed to rescue the United Nations negotiators, if the Chinese and North Korean armies attempted to take them prisoners.

TBG – Was the "clutch" platoon working alone or were they supported by other Marine units?

GTC – Actually, whenever the truce talks were taking place, "D" company, supported by a company of tanks, waited just behind the line to support the rescue party. The site of the talks was approximately one mile inside "no man's land," which is the area between the UN lines to the south, and the CCF/North Korean lines to the north. I figured out some time later that this would have been a suicide mission for the rescuers; the "clutch" platoon and "Dog Company" as well.

TBG – What stands out in your mind about your time in combat?

GTC – My most vivid recollections are of the last few weeks of the war, during July 1953. We had been moving around where there was a lot of action and acting as ready reinforcements wherever needed. The nights were the most dangerous because that was when all the action took place. I particularly recall the constant artillery and mortar bombardments and the fact that we got very little sleep. When I did sleep, it was usually in some muddy trench.

Around the 20th of July 1953, the 2nd Battalion was assigned to reinforce the 7th Marine Regiment on the MLR. We were moved up on the line on the west side of Combat Out Post (COP) "Boulder City," on Hill 119. The

Chinese were focused on trying to secure Boulder City because it would give them a foothold across the Imjin River, a main river running from North Korea down to the sea at Inchon, in the south. More importantly, it would also give them a direct shot into Seoul, the South Korea capital, which was only 35 miles away.

On the 24th of July, we were told to expect heavy artillery and mortar fire as the CCF was expected to mount an assault to gain ground, particularly Boulder City on Hill 119. That night we were under constant artillery and mortar fire.

TBG: (Later, military historians Meid and Yingling (U.S. Marine Operations in Korea, Vol. V., Operations in West Korea) documented that it was the heaviest bombardment of the war, with an estimated 125-150 rounds per minute coming in on that site. The total estimate of artillery and mortar rounds received at that location exceeded 46,000 for that period).

TBG – Can you tell us what it was like during the bombardment?

GTC – During the night of the 24th we were under constant bombardment, as I said. It seemed I was getting bounced off the deck every minute and eating a lot of dirt. During this night we had a number of Marines in our platoon that were wounded, some quite severely. I helped carry out three wounded men from my squad. One, Corporal Angelo Afilani, from Philadelphia, would have bled to death if we had not gotten him to the rear area aid station.

TBG – Your positions were in trenches, like we have seen used in World War I, right?

GTC – I sure wished they were. In reality, we had our own firing positions along the trench line, which were dug pretty deep and provided us some level of protection. However, whoever dug the connecting trench, particularly the one to the rear area, really dropped the ball. While carrying out the wounded Marines on stretchers, many times we would literally run out of trench and be running across open ground, while receiving the heavy artillery and mortar fire. Other times we would be in trench lines that were so narrow our hands holding the stretcher would be scraped along the sides. My hands took several months to heal.

TBG – Did you have any other "close calls" while on the line?

GTC – Well, actually that same night, after taking out the third wounded Marine, when I returned to my fighting hole I discovered it had taken a direct hit. While I was not too happy that I had to dig out my fighting hole, I realized that I had been saved because I was out helping to evacuate a wounded Marine.

TBG – Were you ever wounded?

GTC – Yes. On the last night of the war, actually the early hours of 27 July 1953, the Chinese had again maintained a heavy bombardment in an effort to gain as much ground as possible before the official Cease Fire took effect. I was wounded by shrapnel from a mortar round that landed right next to my fighting position. I guess the Chinese were really out to get me!

TBG – What awards did you receive at the end of the war?

GTC – By the time of my discharge in 1955, I had received the Purple Heart Medal; National Defense Service Medal; Korean Service Medal (3rd Award); U.N. Service Medal; Korean Presidential Unit Citation; and the Marine Corps Good Conduct Medal.

After assisting in the evacuation under fire of the three wounded Marines on 24 July 1953, my Platoon Leader advised me I was being put in for the Bronze Star Medal with Combat V device for Valor. I remained in Korea until July 1954. *I never got the medal*!

(TBG Note: Over the last 12-14 years efforts have been made to secure the Bronze Star that George so well deserves. Despite the support of General Al Gray, USMC, former Commandant; General Peter Pace, USMC, former Chairman, Joint Chiefs of Staff; and several Congressmen and retired General grade Marine officers, the Marine Corps will not issue the Medal since there is no Commissioned Officer that can verify, from personal

knowledge, actions which would support the recommendation for the award. The 1st Lieutenant who was George's Platoon Leader, and witnessed his actions, later died in a Marine Corps aviation accident, and the Captain who was the "D" Company Commander to whom the Lieutenant made the recommendation later died in a freak accident while duck hunting. Despite sworn affidavits from various enlisted Marines who were present, including the wounded evacuees, as well as the Navy medical Corpsman who ordered the evacuation of the wounded, the Marine Corps and/or the Secretary of the Navy, will not take any action on this recommendation.)

A MAN WHO TOUCHED MANY

George Cameron Vail was a man who certainly knew a lot, and touched many people during his 91 year life. Few of you will remember our connection to Mr. Vail, but I assure you, after reading his lengthy obituary, published by the Henry Funeral Home in Audubon, New Jersey, you will be impressed upon the man that touched more Jersey Troopers than you can imagine, without you ever of having had the pleasure of meeting him.

George Cameron Vail (February 22, 1922 – December 17, 2013)

George C. Vail of Audubon New Jersey died on December 17, 2013, from complications associated with aging. For the past three years, George was a resident of the NJ VA Home in Vineland. He lived a full and happy life, understood when his life was near its end, and accepted his impending death gracefully.

George was born in Ecorse, Michigan, a rough and tumble depression era steel town "downriver" from Detroit. He was one of five siblings raised in meager circumstances during a very difficult time. Although he showed an early artistic aptitude, the main focus of life for him as a boy and young man was seeking ways to help his family. Part of that sacrifice for George was the need to leave high school at age sixteen to seek work and find direction.



During the next four years George worked at several different jobs that presaged the unique and multi faceted intellect that he possessed. Despite the lack of formal education, George demonstrated an enormous capacity to learn solely from reading. He voraciously consumed books on art, literature, history, geology, electronics, and mechanics.

George also met the woman he would marry, Mary Ann Snyder, during this time. They were a young couple very much in love and doing their best to figure out how to face a future during tough economic times and an all consuming war. Kathleen was the first child born from their union, followed over the next fourteen years by Maureen, Terrence, Althea, Cynthia, and Scott.

In what would be one of the defining periods of George's life, he entered the US Army during World War II and was sent to New Guinea and the Philippines. In addition to his role as an infantryman, George provided his unit with hand-drawn maps and sketches depicting scenes of the many battles that were fought. He was wounded during combat and received a Purple Heart and Bronze Star for his service. One of George's proudest accomplishments during his military time was achieving the rank of Master Sergeant.

After the war, George returned to Michigan where he began working for Diamond Power Specialty Corporation, a maker of industrial boilers. It was a transfer within Diamond Power that resulted in George and Mary Ann relocating to Audubon, which would remain their home for the rest of their lives.

Besides holding down a full-time job and personally doing extensive construction on the tiny Oak Street house that he and Mary Ann had managed to buy, George's innate knowledge and talents began to emerge full bore. He spent his nights and weekends immersed in the arts that included painting, sculpting, calligraphy, woodworking, jewelry making, and teaching. Outside of his artistic endeavors, he designed and received patents for industrial boilers; received his professional mechanical engineer's license; returned to school and received his bachelor's

degree; founded two local newspapers – The Suburban and the Oaklyn Element; was a ham radio operator who assembled his own transmitter/receiver; and hand-built guitars late into his life.

In 1960, George, Mary Ann, and their six children moved into what the locals referred to as the Mansion House in Audubon. At the time, the two hundred year old Mansion House was in total disrepair with scores of broken windows, decrepit plumbing, and an archaic electrical system. Through George's and Mary Ann's long-term dedicated efforts, the Mansion House was slowly brought back from the brink, and became their family's loving home for over fifty years.

George served tirelessly for many years as a member, and as President, of The Batsto Citizens Committee. He was very involved with The Camden County Historical Society and maintained an intense interest in the history of Southern New Jersey. George provided forensic sculptings to the Camden County Prosecutor's Office to assist in identifying unknown persons. He was active in the Audubon Pioneers Club, twice ran for local office in Audubon, and was a member of the American Legion Murray-Troutt Post.

What George may be best remembered for were the qualities he brought to those who knew him as a teacher. There are legions of individuals who benefitted from his practical, straightforward, and often direct style of teaching. George's teaching assignments included fine art instruction at the Haddonfield Art League and Jewish Community Center, art at Leesburg State Prison, GED at Gloucester County Prison, mechanical and architectural drawing at Ryder Technical Institute, commercial art at Gloucester County Institute of Technology, and painting, drawing, and computer art at Gloucester County College. There are also those students who found their way to George's beloved Carriage House Studio where art, conversation, and humor often shared equal billing.

In appreciating George's life it is important to remember him as a son, brother, husband, father, uncle, grandfather, great grandfather, and great-great grandfather. He survived a terrible war and outlived most of his contemporaries. He could be distant to those closest to him, yet loved to rock babies to sleep and surprise kids with pockets full of candy. He could be profane, but notably articulate. He was an intractable homebody rarely leaving the confines of South Jersey, yet someone who knew significant things about the world through books. He was often cantankerous, but had a soft spot for those less fortunate in life and who frequently ended up being taken under his wing. George was a good man with enormous talent. His passing saddens all those who knew him.

George is survived by his six children, eleven grandchildren, thirteen great grandchildren, one great-great grandchild, many nieces and nephews residing in Michigan, and his remaining sibling, Betty Pasik of Allen Park MI

A memorial service for George will be held at Henry Funeral Home located at 152 West Atlantic Ave., Audubon on January 3, 2014 from 5:00 to 8:00 PM followed by a remembrance gathering at the American Legion Murray-Troutt Post #262, 20 Chestnut Street, Audubon. George will be laid to rest in Michigan at a later date.

The Vail family wishes to thank the staff at the NJ VA Home for the attention they devoted to George, especially those who provided his individual care with patience and tenderness.

A lover of trees and historic places, George asked that, in lieu of flowers, donations be made in his memory to the Batsto Citizens Committee, Inc. (BCCI, 4110 Nesco Road, Hammonton, NJ, 08037) for natural and historical landscape restoration.

Now that you've come to know who George C. Vail was I'm sure you're a bit perplexed how he could have possibly touched any of you. Well, if you happened to have a copy of the "N.J.S.P. Barracks" painting hanging on your wall you can thank Mr. Vail for making that print happen. Yes, thanks to Mr. Vail and his close personal relationship with DSFC Joseph M. Getsinger, #2697(Ret), they made that painting a reality. It's true; George Vail had been a teacher and mentor to Joe Getsinger which grew into a great friendship.

Joe set up and photographed the "Barracks" scene at Bordentown Station in 1978. The gun and holster were borrowed from then Trooper William H. Hillis, #2785. Joe had been issued a Smith & Wesson pistol and didn't think it was appropriate at the time since the Colt was our traditional pistol. While the Barracks painting was

certainly Joe's creation, it came at a time when the State Police would not permit a Trooper to benefit in such a manner. As such, Joe and George collaborated on the painting with Joe's creation being painted by George, under George's signature. This project, as was told, helped the Banquet Committee greatly at the time.

So, for all of you who have a copy of that wonderful painting hanging on your wall, you now know and can appreciate how it came to be, thanks to Joe Getsinger and his friend George Cameron Vail. And, for those of you interested in obtaining a personalized copy of that famous painting, stop in at the FTA Logo Merchandise Store at Division Headquarters, we have the "Barracks" print and Joe's other NJSP and military prints readily available.

CREDIT CARD SCAM

This scam is reportedly happening in the Midwest right now, and moving across the country. It's really pretty slick, since the scammers provide you with all the information, except the one piece they want. Note, the callers do not ask for your card number - they already have it. By understanding how the VISA & MasterCard telephone Credit Card Scam works, you'll be better prepared to protect yourself.

The person calling says something like this, "This is Investigator Smith and I'm calling from the Security and Fraud Department at VISA. My Badge number is 12460, and your card has been flagged for an unusual purchase pattern, and I'm calling to verify. This would be on your VISA card which was issued by (name of bank). Did you purchase an Anti-Telemarketing Device for \$497.99 from a marketing company based in Arizona?" When you say 'No', the caller continues with, "Then we will be issuing a credit to your account. This is a company we have been watching, and the charges range just under the \$500 purchase pattern that flags most cards. Before your next statement, the credit will be sent to (gives you your address). Is that correct?" Of course you say yes.

The caller continues, "I will be starting a Fraud Investigation. If you have any questions, you should call the 1-800 number listed on the back of your card (1-800-VISA) and ask for Security. You will need to refer to this Control Number (The caller then gives you a 6 digit number). Do you need me to read it again?"

Here's the IMPORTANT part on how the scam works. The caller then says, "I need to verify you are in possession of your card." He'll ask you to turn your card over and look for some numbers. There are 7 numbers; the first 4 are part of your card number, the last 3 are the Security Numbers that verify you are the possessor of the card. These are the numbers you sometimes use to make Internet purchases to prove you have the card. The caller will ask you to read the last 3 numbers to him. After you tell the caller the 3 numbers, he'll say, "That is correct, I just needed to verify that the card has not been lost or stolen, and that you still have your card. Do you have any other questions?"

After you say no, the caller then thanks you and tells you not to hesitate to call back if you do, and then hangs up. You actually say very little, and they never ask for or tell you the card number. What the Scammer wants is the 3-digit PIN number on the back of your card. Don't give it to them. Instead, tell them you'll call VISA or Master Card directly for verification of their conversation, and hang up.

The real VISA explains that they will never ask for anything on the card, as they already know the information, since they issued the card! If you give the Scammer your 3 Digit PIN Number, you think you're receiving a credit. However, by the time you get your statement you'll see charges for purchases you didn't make, and by then it's almost too late and/or much more difficult to actually file a fraud report. It appears that this is a very active scam, and evidently quite successful.


Any person interested in the scholarship must complete and submit an application to the Secretary of "The Fund." The application can be found on *page #37* of this newsletter.
