### **COLONEL'S COMMENTS**



Greetings from Building 1at Division Headquarters. I would like to start with a brief note of thanks to Nick Soranno and George Wren, and to all of the Officers and Board of Directors from the FTA who recently appointed me as an "Honorary" member of the Association of Former New Jersey State Troopers. I, along with all of the Division, look forward to our continued partnership and sharing in the comradery which continues to be strengthened through our efforts to support one another.

I also would like to take this opportunity to offer a few updates with regards to a few topics associated with the Division. The 158<sup>th</sup> State Police Class entered the Academy at Sea Girt on January 29, 2018 with 213 recruits. As of the last week in March, 177 recruits remain in training. Although they have a long way to go, those who are successful in completing the training are scheduled to graduate and become our newest troopers on July 13, 2018. I am also happy to report that we have received approval for the 159<sup>th</sup> Class which is due to start training in January of 2019. As of this writing, we have navigated 4 nor'easter snow storms and the men and

women of the Division, particularly the enlisted and civilian members within Field Operations and Emergency Management, worked tirelessly to ensure the State's appropriate preparedness and response to these storms. During one of the storms, Governor Murphy took the time to visit with road troopers at Holmdel Station, and he also visited with all of our members and state partners staffing the State Emergency Operations Center, so he could offer his gratitude in person for their efforts.

Attorney General Gurbir Grewal and I have collaborated on several issues over the past few months including community engagement efforts, combatting violent crime, the opioid epidemic, and enhancing community policing strategies, particularly as they pertain to school safety. Together, it is our goal to visit all 21 counties and attend town hall meetings in what the Attorney General is referring to as "21 County – 21st Century Community Policing Project." We are hoping these meetings foster continued public trust and a sense of transparency between law enforcement and the public we serve.

As a means of keeping the lines of communication open between my office and the members of the Division, I just completed my first run with 22 troopers that were Field Operations representatives from all four troops. We all headed to the tow path along side of the Delaware River for a 2-mile PT session. Afterwards, we suited up in our Class A Winter Blouses with full leather and I was thrilled to march the detail from the gymnasium down to the Log Cabin for a few photos to commemorate this run. We then headed back to my conference room where we had lunch and discussed the challenges facing the road troopers today. The discussion incorporated topics such as body worn cameras, contract negotiations, training, school safety, communications, clothing and equipment issues, as well as just an open dialogue and opportunity to connect with troopers. I told them that although the conference room table is regularly surrounded by commanders, I find it just as important that we continue to surround that table with young road troopers, so I can work to remove the obstacles they encounter every day. It is my hope to have one of these PT sessions once a month with members from all Branches of the Division.

Lastly, an issue impacting all of our retired troopers is the retirement ID that is issued upon retiring in good standing. It was relayed to my office that the larger, bill fold IDs are too large for those that just carry a wallet. Starting immediately, the Division will be issuing an additional retirement ID card that is the size of a driver's license. This will especially assist those retired members required to carry their ID card if they are carrying a firearm under the RPO program. We will be rolling out a process through the FTA and the Division to facilitate the issuance of these smaller IDs to those retired members requesting one. We hope to coordinate this process in a manner which does not put undue stress on our Forensic Photography staff.

The troops are looking forward to transitioning into the Class A Summer shirts come April 1<sup>st</sup> and after this winter, so am I. Hope to see you all at the SP Chase on May 19<sup>th</sup> at Division Headquarters. Governor Murphy, the First Lady, and the Attorney General have all registered for this 5k race and I hope to be setting the pace! Stay safe out there.

Since taking over in January 2018, vice president George Wren and I, along with the executive board and directors, have re-organized the three entities with the formation of specific committees, along with a newly formed Finance Advisory Council. Communication between these three entities is paramount to accomplishing our goals and objectives, including expanding benefits to our members, while sustaining our financial stability for many years to come.

Over the next two years, I have an agenda which addresses specific issues and concerns. This will aid in our aggressive campaign to fund all our projects, including the scholarship programs and most importantly, the building fund to construct the Columbarium around the statute in the courtyard of the Museum and Learning Center.

I look forward to seeing all of you at our General Membership Meetings, the annual picnic, and all our other statewide social events scheduled this year. God bless all of you and your families, and God bless the New Jersey State Police.

According to Chairman Tretola,

The Seven Seals Award is the broadest and most inclusive award given by ESGR and is presented at the discretion of the State Chair or by ESGR senior leadership at National. The Seven Seals Award is only given on a State or Federal level and is presented in recognition of significant individual or organizational achievement, initiative, or support that promotes and supports the ESGR mission, to include the efforts of the more than 4,500 volunteers who carry out ESGR's mission across the Nation on a daily basis.

The Statement of Support Program is the cornerstone of ESGR's effort to gain and maintain employer support for the Guard and Reserve. The intent of the program is to increase employer support by encouraging employers to act as advocates for employee participation in the military. Supportive employers are critical to maintaining the strength and readiness of the Nation's Guard and Reserve units.

The first Statement of Support was signed December 13, 1972, in the Office of the Secretary of Defense by the Chairman of the Board of General Motors. President Richard Nixon was the first President to sign a Statement of Support, and in 2005 every Federal Cabinet Secretary and all Federal agencies signed a Statement of Support to signify their continuing efforts to be model employers. Since its inception, hundreds of thousands of employers have signed Statements of Support, pledging their support to Guard and Reserve employees.

A memorial service was held at Leechester Hall in Maurice River Township, in memory of fallen New Jersey State Trooper Frankie Williams, Tuesday March 6, 2018. An area of Rt 55 between mile post 20 and 23 where Williams was killed in a crash while responding to a call is named in his honor.

I also had the honor of attending the 33<sup>rd</sup> Annual Atlantic Cape 200 Club Brunch on March 11, 2018, at the Tropicania Casino Hotel. I've been a member of this 200 Club Chapter for many years and strongly support it and all the 200 Club Chapters for the outstanding support they provide to the families of fallen responders. Of particular interest this year was the tribute paid to Peggy Mallen-Walczak by the Atlantic City Fire Department.



As you know, Peggy lost her husband Detective I Albert J. Mallen, #2753 on August 28, 1985, when he was shot in the line of duty, and this past summer her son Albert "Albie" Mallen, Jr., also passed away. Peggy explained how at the time of her husband's death, she had less than \$100, and struggled with the costs of his funeral and raising their three children. Her family received a donation from the Ocean and Monmouth Counties 200 Club, and it inspired her to start a chapter in Atlantic and Cape May counties. "This created something positive out of something negative," she said. "My children had to wait until my husband's death for him to be called a hero. We raise money to help families through it, and to honor first responders for what they do now."

Peggy's Son Albie, was a well-known and decorated scholar athlete, who attended Holy Spirit High School and Rutgers University. His selfless and generous personality was manifested during an almost 20-year, dedicated and accomplished career as an Atlantic City Firefighter. His spirit of community service was also apparent in his volunteerism in coaching youth sports. Please be advised, the 1st Annual Air Mallen Open Golf Tournament has been established, and is scheduled for August 15, 2018, at the McCullough's Emerald Golf Links in Egg Harbor Township. The exhibit features historical information, pictures and artifacts on the planning, selection process, and training of the first all-female state police class in the country, the NJSP 96<sup>th</sup> Class. The exhibit was put together by the Recruiting Unit with Trooper Aileen Clowes, #7292, taking the lead assisted by State Police Archivist, Mark Falzini. Stop by the Museum and check it out!

Lastly as you well know, I continue to keep in contact with our own 'Marathon Man,' and 2016 recipient of the FTA Former Trooper of the Year Award, Lt. John Ouweleen, #1759 (*Ret*), here's his latest update:

I am pleased to provide you an update, with something of interest. To reiterate, The Space Coast Half Marathon was to be a World Record attempt, however with the injury sustained in Tulsa OK, that became impossible. Post the Space Coast race, I continued to run, however the hamstring injury was ever present. Therefore, I continued to be cautious and conservative. Then out of nowhere, on January 10, 2018, after ten weeks of discomfort, the pain relinquished, and I was able to run comfortable again. Hallelujah.

This sudden change hatched a new dream. I discovered that the World Record for Male 77 in the 15K (9.3) miles was set two years ago in Tampa Florida. The race, Tampa-Gasparilla Classic, is a race that I ran in 2017, but in the Half Marathon version. In addition, the runner who set the World Record, Joseph Burgasser of Tampa, Fl., is an acquaintance, and fellow competitor. Joseph already has a legacy in Road Racing. He holds World Championships, National Championships, World Record holder in the 15K, course records, and defending (2017-2018) age group (75-79) Tampa-Gasparilla champion. He is also incorporated as a Forerunner coaching, licensed USATF Coach. The Tampa-Gasparilla course, is his home field. What an opportunity to get back into the mix.

I registered for the race which was scheduled for February 24, 2018. My goal was two-fold, win the race, and break Joseph's World Record individual age time.

The race went off on time with light winds, but with extremely warm conditions. At the half way turn around, I had a meager 20 second lead, but I hit it heavy on the return to win the race with a sizeable difference. I ran a 1:13:31, and Joseph's second place time was 1:16:27. Two minutes and fifty seconds to my benefit. Unfortunately for me, Joseph's 77-year individual age record still stands. Maybe next time.

I am presently feeling fine, and training regularly. The Boston Marathon is two weeks away, April 16, 2018, and I am prepared to do my best.

In December 2017, I was bestowed the honor of "The Lifetime Achievement Award," by the Sunrunner of Vero Beach Fl., Running Club. Only the 2nd person to receive such an award in the 39-year history of the club.

And, just last week, I was contacted by the Space Coast Runners, running club, offering me the opportunity to represent the club at the upcoming Boston Marathon. I will be representing the club as a team member, 3 male members per team. There will also be a 3-member female team.

So that's the update. The number one thing is that I am healthy, ready to compete, and represent the good old New Jersey State Police/Former Troopers Association.

### Lt. "Turnpike" Tony Vuolo, #1422 (aka TV)

Lieutenant Anthony J. Vuolo, #1422 is a member of the 48<sup>th</sup> Class and graduated from the Academy in West Trenton on May 1, 1955. His career spanned over thirty years and he retired as the Troop "D" Moorestown Station Commander on September 1, 1985. Starting out as a "B" Trooper, he broke in and spent his first year in the Outfit at Washington Station, Warren County. His next assignments were at the Pompton Lakes and Ramsey Stations. In 1958 he was assigned to Troop "D" Newark Station and spent the rest of his career, 27 years, on the New Jersey Turnpike.

Born on April 19<sup>th</sup>, 1928, Anthony J. Vuolo grew up in the Sandy Hill section of Paterson, NJ and attended School 11, School 15 and Eastside High School. In 1943 he played football at Eastside High but after suffering an injury he left school and went to work for Curtis Wright Aeronautical. He subsequently returned to school and the football team in 1946. After leaving high school in 1946 he joined the Army Air Corps., completing his basic training in Fort Dix, NJ. From there he was stationed in Fort Lee, VA, San Juan Puerto Rico and Trinidad where he completed his military service.

After his discharge from the Army he attended Art School on the G.I. Bill for one year further honing the natural artistic talents he possessed throughout his childhood. He became proficient at sketch drawing and calligraphy.

Tony met his beloved wife Ann Eilersen in 1945. They married in 1950 and lived on 38<sup>th</sup> Street in Paterson for ten years. They bought a home and moved to Midland Park, NJ in 1960, a "home" they still reside in to this very day. They have been blessed with four children, Chuck, Wendy, Anthony and Marie. They have ten grandchildren and twelve great grandchildren. On April 19<sup>th</sup> this year Tony will celebrate his 90<sup>th</sup> birthday. Ann will celebrate her 89<sup>th</sup> birthday in April as well.

From 1949 to 1954 Tony worked in the textile industry in Paterson as a Sketch Maker. He also did other odd jobs to make ends meet because the textile industry in Paterson was declining and relocating to the New England area. Seeking steady employment and "guaranteed" benefits he applied to become a member of the NJ State Police in 1954 and entered the 48th Class in 1955.

During the 67 plus years they have lived in Midland Park, Tony and Ann have been very active in their community. In September 1992 the Bergen County Executive awarded Tony a Certificate of Commendation for "Outstanding Volunteer of the Year," chosen for his distinguished and dedicated volunteerism to the community. In June 2001, Tony and Ann received the Town Council Award in recognition of their years of service and dedication in founding and supporting Midland Park Youth Olympic Day. Tony also received a Proclamation from the Office of the Mayor of Midland Park for his service on the Board of Recreation from 1974 through 2001; as a member of the Booster Club from 1968 through 2001; as a Founding Father and 1st president of the Junior Football League; for founding the Powder Puff and Men's Softball Leagues; Olympic Day; Art Director for 3 High School Graduation Balls; beautification of a number of public areas in the Borough and he was also granted the "Top Cop" Award and Citizen of the Year in 1981. Tony has been a member of the Midland Park American Legion for 48 years. In 2017 he and Ann were inducted into the Midland Park High School Athletic Hall of Fame.

Throughout their lives and Tony's State Police career, Tony and Ann have had the good fortune to rub elbows with some historic figures and entertainment stars. His father-in-law, Charles Eilersen, was a chauffeur for Senator Dwight Morrow and his family. In addition to Mr. & Mrs. Morrow he drove Charles Lindbergh, his wife Ann Morrow Lindbergh and servant Betty Gow in the early 1930s during the Lindbergh Baby kidnapping investigation. He made many trips back and forth between Englewood and Hopewell, NJ during that time and was interviewed by investigators during the course of the investigation. Mr. Eilersen told Tony that the Morrow vehicle he drove was a 16-cylinder Packard. On several occasions driving from Englewood to Hopewell he said the Troop Cars accompanying him were unable to keep up with the Packard.

As a child, Ann Eilersen remembers being at the Morrow residence in Englewood. Ann Morrow Lindbergh, herself a pilot, was very good friends with Amelia Earhart. On occasion Amelia Earhart came to the Morrow residence bearing candy treats for young Ann Eilerson.

As a young Trooper patrolling the NJ Turnpike, "TV" was working Newark Station's northern area one summer Sunday afternoon. Trooper Mike Cermak #1498 was patrolling Newark's southern area and called Tony on the radio advising him that he had "a friend" of his stopped in Elizabeth and requested that he Signal 26 with him. When Tony arrived on scene he observed Trooper Cermak speaking to a gentleman he later learned was Pinky Jackson. Pinky was an animal trainer and was travelling with a chimpanzee named Cheetah. Cheetah was the animal actor who starred with Johnny Weissmuller in the Tarzan movies, popular during the 1930s and 1940s. At some point during the roadside encounter they had Cheetah dismount from his trailer and Pinky told Cheetah to "do Marilyn Monroe." At that point Cheetah rolled back his lips exposing his teeth and presented a broad grin, flashing a smile at the two Troopers. A command decision was then made to bring Cheetah back for a "guest tour" of Newark Station. Trooper Vuolo had Pinky instruct the chimp to sit in the right front seat of his Troop Car for the trip. Trooper Cermak and Pinky followed in the other cruiser. Trooper Vuolo placed his Class "A" hat on Cheetah's head and proceeded north toward Newark Station in search of the "the right car." The right car was a station wagon with a bunch of kids in the rear, mom and

dad up front, haggard and tired, returning from a day down the Jersey shore. As Troopers always do, Trooper Vuolo found his mark. He pulled up into the vehicle's "blind spot" and the kids in the rear immediately focused on the Troop Car and the funny looking "Passenger Trooper." With that, Trooper Vuolo told Cheetah to "do Marilyn Monroe." Cheetah complied, and the kids went wild and began poking and prodding their parents to get them to look back. Then the Troop Car pulled up alongside the driver who finally looked over. You can imagine the shocked look on the driver's face. As his mind tried to reconcile what his eyes had just seen, the Chrysler's four barrels kicked in and the Troop Car disappeared over the horizon.

At the station Cheetah was introduced to Troopers William Napierski, #1267 and Ray Chiappelli, #1281. While on his station tour Cheetah was placed on the "the book," wearing a visor belonging to one of the Sergeants. He also was given a demonstration on fingerprinting procedures, but instead of cleaning off the fingerprint table with the 100-proof moonshine kept on hand for "just" that purpose, he chose to drink it at the Troopers dismay. Pinky explained that Cheetah acquired his taste for "adult beverages" after accompanying Johnny Weissmuller on several lunchtime filming breaks at a local gin mill. "Feeling good," Cheetah began tightrope walking acrobatics on the handcuff bars in the lock up area, frolicking with the Troops. After his antics at the station, Pinky took him into the men's room, so he could relieve himself. As the chimp stood in front of the toilet bowl Pinky asked him, "did you forget something?" Cheetah then picked up the toilet seat and proceeded to relieve himself.




During his tenure on the Turnpike, Trooper Vuolo made such an "impact" with his presence at Newark Station that he is the only **living** Trooper to have a section of highway named after him. The "impact" occurred between his Troop Car and a civilian vehicle at the 112 U-turn on the SNE roadway, and ever since, the site has been officially designated as "Vuolo Curve."

History again touched on "Sergeant TV," later on in his career. The Newark Station Commander's Office proudly displayed a framed, under glass, copy of the Declaration of Independence. As most of you know the Declaration of Independence was adopted by the Second Continental Congress in Philadelphia on July 4, 1776. What you probably

didn't know is that there were several people who were supposed to sign the document on that day in history but were unable to make it to Philadelphia due to transportation difficulties, as well as "delayed birth dates." Newark Station's proximity to major highways and Newark Airport made it the hub and obvious rally point for these **Patriots** to muster and sign the coveted historic document. Several of these **belated signers** were friends of Newark Station personnel, and also included the Station Commander and his wife, Jim and Louise Longo. As luck would have it Sergeant Vuolo happened to be working on the days these historic figures showed up and was able to witness them affixing their signatures to the document.

During his tenure at Newark Station and as the Squad 5 Supervisor, TV produced several sketches and caricatures depicting many facets of the State Police experience and its members. Included in these sketches were t-shirt logo designs, one of which was the first rendition depicting the Turnpike as "The Black Dragon" (pictured below). If you look closely you will see that he used Lt. Nick Zichello, #3077 (*Ret*) as his model for the Trooper riding the dragon. ### 2017 FORMER TROOPER OF THE YEAR AWARD

Joseph M. Paulillo, #2028, graduated from the New Jersey State Police Academy on September 13, 1965, as a proud member of the 68th Class. After serving at various Troop 'C' Stations, then Trooper Paulillo was assigned to the State Police Academy as an Instructor, where he presented courses to state & municipal police, pre-service and basic training programs, in-service, supervision, and management training programs. While at the Academy, Joe was designated as Supervisor and Coordinator of several NJSP initiatives, including the Seton Hall University Higher Education Program, community youth relations, and the Trooper Youth Week programs, as well as Domestic Terrorism training for law enforcement managers, sponsored by the Department of Justice.

Moving up through the ranks while at the Training Academy, he was appointed to the position of Assistant Bureau Chief of the Academy, and later served as Bureau Chief of the Planning Bureau and the Traffic Bureau. After serving 26 years as a Jersey Trooper, Captain Paulillo retired from State Police service on September 1, 1991.

Upon leaving the State Police, Joe volunteered in his community at Plumsted Township, reviewing a plethora of police/community, emergency management, substance abuse, and crime prevention projects and programs, and served on the Township Land Use Board. As a consultant to Triangle Enterprises Inc., he assessed the Elizabeth City School District school security operations, and ultimately developed a district-wide, school guard policies and procedure manual, as well as a program of training school guards.

In 1993, Joe was hired by the New Jersey Attorney General and assigned to the Division of Criminal Justice where he was appointed State Administrator for the New York/New Jersey High Intensity Drug Trafficking Program (HIDTA), sponsored by the Office of National Drug Control Policy (ONDCP), Office of the President. After the September 11, 2001 terrorist attacks, Joe was re-assigned to the New Jersey Office of Counter-Terrorism as a counter terrorism intelligence analyst. Joe also worked on document and identity fraud with the Division of Consumer Affairs.

In his retirement, Joe established an Internet web site called, "The Jersey Trooper" on September 16, 2015, and a subsequent Facebook page where he actively solicits and posts historic and current State Police related information towards preserving the history of our esteemed "Outfit" of Jersey Troopers.

A member in good standing of the Association of Former New Jersey State Troopers, Joe is also a member of the International Association of Chiefs of Police, the International Association of Law Enforcement Intelligence Analysts (IALEIA), and the New Jersey State Narcotics Officers Association (NJSNOA). Additionally, Joe is also a member of the Hoboken High School Sports Hall of Fame, where in 2012 he was recognized for playing four years of football and inducted into their Sports Hall of Fame.

Joe Paulillo received a Bachelor of Science Degree in Business Education from the College of New Jersey and a Master of Arts Degree in Public Administration from Rider College.

Highly recommend for his distinguished career and achievements, Captain Joseph M. Paulillo, #2028 (*Ret*) was awarded the 2017 Former Trooper of the Year Award at the FTA Fall General Membership Meeting on November 4, 2017. His actions serve as a testament to the fortitude, character and initiative of our members after they leave the active rolls of the New Jersey State Police.

### HISTORICAL HIGHLIGHTS

### TWO GREAT STORIES - BOTH ARE TRUE!

Editor's Note: From time to time I received stories and leads about historical highlights that are truly inspiring. I try to make sure that before considering them for inclusion in this publication, they have some connection to our Outfit of Jersey Troopers. However, some stories just have to be shared, and this is one of them. A special thanks to SFC Timothy M. O'Riordan, #3046 (Ret) for sending in this story. Enjoy!

#### **STORY NUMBER ONE:**

Many years ago, Al Capone virtually owned Chicago. Capone wasn't famous for anything heroic. He was notorious for enmeshing the windy city in everything from bootlegged booze and prostitution to murder. Capone had a lawyer nicknamed "Easy Eddie." He was Capone's lawyer for a good reason. Eddie was very good! In fact, Eddie's skill at legal maneuvering kept Big Al out of jail for a long time.

To show his appreciation, Capone paid him very well. Not only was the money big, but Eddie got special dividends, as well. For instance, he and his family occupied a fenced-in mansion with live-in help and all the conveniences of the day. The estate was so large that it filled an entire Chicago city block.

Eddie lived the high life of the Chicago mob and gave little consideration to the atrocity that went on around him. Eddie did have one soft spot, however. He had a son that he loved dearly. Eddie saw to it that his young son had clothes, cars, and a good education. Nothing was withheld. Price was no object. And, despite his involvement with organized crime, Eddie even tried to teach him right from wrong. Eddie wanted his son to be a better man than he was. Yet, with all his wealth and influence, there were two things he couldn't give his son; he couldn't pass on a good name or a good example.

One day, Easy Eddie reached a difficult decision. Easy Eddie wanted to rectify wrongs he had done. He decided he would go to the authorities and tell the truth about Al "Scarface" Capone, clean up his tarnished name, and offer his son some semblance of integrity. To do this, he would have to testify against The Mob, and he knew that the cost would be great. He testified.

Within the year, Easy Eddie's life ended in a blaze of gunfire on a lonely Chicago Street. But in his eyes, he had given his son the greatest gift he had to offer, at the greatest price he could ever pay. Police removed from his pockets a rosary, a crucifix, a religious medallion, and a clipping from a magazine. It read: "The clock of life is wound but once, and no man has the power to tell just when the hands will stop, at late or early hour. Now is the only time you own. Live, love, toil with a will. Place no faith in time. For the clock may soon be still."

#### **STORY NUMBER TWO:**

World War II produced many heroes. One such man was Lieutenant Commander Butch O'Hare. He was a fighter pilot assigned to the aircraft carrier Lexington in the South Pacific. One day his entire squadron was sent on a mission. After he was airborne, he looked at his fuel gauge and realized that someone had forgotten to top off his fuel tank. He would not have enough fuel to complete his mission and get back to his ship.

His flight leader told him to return to the carrier. Reluctantly, he dropped out of formation and headed back to the fleet. As he was returning to the mother ship, he saw something that turned his blood cold; a squadron of Japanese aircraft was speeding its way toward the American fleet.

The American fighters were gone on a sortie, and the fleet was all but defenseless. He couldn't reach his squadron and bring them back in time to save the fleet. Nor could he warn the fleet of the approaching danger. There was only one thing to do. He must somehow divert them from the fleet.

Laying aside all thoughts of personal safety, he dove into the formation of Japanese planes. Wing-mounted 50 calibers blazed as he charged in, attacking one surprised enemy plane and then another. Butch wove in and out of the now broken formation and fired at as many planes as possible until all his ammunition was finally spent.

Undaunted, he continued the assault. He dove at the planes, trying to clip a wing or tail in hopes of damaging as many enemy planes as possible, rendering them unfit to fly. Finally, the exasperated Japanese squadron took off in another direction.

Deeply relieved, Butch O'Hare and his tattered fighter limped back to the carrier.

Upon arrival, he reported in and related the event surrounding his return. The film from the gun-camera mounted on his plane told the tale. It showed the extent of Butch's daring attempt to protect his fleet. He had, in fact, destroyed five enemy aircraft.

This took place on February 20, 1942, and for that action Butch became the Navy's first Ace of WWII, and the first Naval Aviator to win the Medal of Honor.

A year later Butch was killed in aerial combat at the age of 29. His home town would not allow the memory of this WW II hero to fade, and today, O'Hare Airport in Chicago is named in tribute to the courage of this great man.

So, the next time you find yourself at O'Hare International, give some thought to visiting Butch's memorial displaying his statue and his Medal of Honor. It's located between Terminals 1 and 2.

### MILITARY NEWS

### BECAUSE HE WAS OUR BROTHER


Recently, an event occurred that supports and demonstrates the comradery that we proudly share as submariners. The event occurred as follows:

During the summer of last year an unidentified man walked unannounced into the VFW Post in Wildwood, NJ and placed a sealed urn on the bar which contained the ashes of an individual that he described only as those of a submariner. He told the bartender "vets will know what to do with the ashes" and departed without further explanation as to how or why he was in possession of the urn/ashes.

The commander of the VFW contacted me, as commander of the nearest submarine veterans base (Egg Harbor New Jersey Base), explained the unusual event and asked if our base would see to the proper disposition of the ashes. Our base retrieved the ashes from the VFW and began the process of trying to properly identify the remains of the individual in question and also ascertain if in fact the person was a submarine veteran. We researched identifiers on the urn and were ultimately able to identify the funeral home that performed the cremation of the individual. The funeral director confirmed that he performed the cremation on October 28, 2014 and identified the remains as those of Harry Edward Harris, DOB February 26, 1920. The funeral director advised that to the best of his knowledge there were no known relatives or family members of Mr. Harris. He further explained that he had no records or knowledge of how or why the urn was in the possession of the unidentified person who left it at the VFW.

Our base researched navy military records for Harry Edward Harris, DOB February 26, 1920 and learned that Mr. Harris was a US Navy veteran and was in fact a submarine veteran. He was awarded the Pacific Theater Ribbon with three stars, the American Theater Ribbon, the Victory Medal, Submarine Combat Pin and Submarine Qualification Pin. His military records revealed that he served as a Yeoman Third Class YN3(SS) aboard the USS Balao (SS285) during the period 15 March 1944 through 7 March 1946.

Our base made numerous inquiries in an effort to locate any living relatives of YN3 (SS) Harris but were unable to



find any information that would be helpful. Therefore, our base concluded that it would be our privilege to give YN3 (SS) Harris a proper military funeral that would be commensurate with his military service. Associate base members Robert Frolow (Veteran Affairs Coordinator/American Legion Post 352 Commander), James Donahue and Frederick Vineyard (AMVETS Post 911) were asked for their assistance with the burial of YN3(SS) Harris. Commander Frolow was instrumental in securing a burial site and requesting a US Navy burial detail be present at grave side. As a result, the navy provided a burial detail, flag bearers and bugler. AMVETS Post 911 provided a color guard and American Legion Post 352 provided side boys. Submarine Veterans Egg Harbor Base Chaplain John Pucci provided a moving eulogy and base sub-vet members served as pall bearers, and interment facilitators.

During the service it was noted that a woman who was passing by the site stopped to observe the burial of YN3(SS) Harris and the military protocol that was being shown to him. She stayed until the conclusion of the service and then approached a group of our sub base members that were gathered by the grave site. The woman approached us and offered her condolences. She stated that the service was very impressive, explained that she had never observed a military service before and found it to be very moving and emotional. She then inquired as to whom the burial was for. We told her of the unusual circumstances under which we obtained the ashes and ultimately arranged for the burial service. She was a little surprised by our explanation and stated, "you mean you did all this for someone you are not related to or never met?" Yes, ma'am was the response. Noting the confusion that seemed to come over her, John Kill (Base COB) came forward with the following explanation: "You see,



Ma'am, it's like this, Yeoman Harris was a veteran, a submarine veteran, therefore he was a brother to all of us. What happened here today was that brothers buried their brother." The woman paused for a moment with her mouth slightly ajar as if trying to comprehend what she had just heard. She then stated, "that is the most amazing thing I have ever heard. Thank God that our country has men and women like you to protect it. God Bless you all and thank you for your service." Thank you, Ma'am, was our response.

### IMPORTANT INFORMATION ALL VETS SHOULD KNOW

The link below will open a list of web-sites that will provide information on Veterans benefits and how to file and/or ask for them. Accordingly, there are many sites that explain how to obtain books, military/medical records, information and how to appeal a denied claim with the VA. Nearly 100% of this information is free and available for all veterans, the only catch is: you have to ask for it, because they won't tell you about a specific benefit unless you ask for it. ### **NEW EXEMPTION FOR VETERANS**

You may recall from previous newsletters, under a new State law enacted in 2016, veterans may qualify for an exemption of up to \$3,000 on their New Jersey tax return for income earned in 2017. This exemption, part of a bill passed by the Legislature and signed into law by Governor Christie last October, is in addition to other exemptions or deductions for which veterans may qualify. The exemption is available for all veterans who received honorable discharges or who were released under honorable circumstances from active duty in the Armed Forces of the United States, a reserve component thereof, or the National Guard of New Jersey in a federal active duty status. Veterans may claim the exemption when they file their Tax Year 2017 returns. For more information, contact the New Jersey Division of Taxation.

### BEAT THE WEP!!!

Over the years, one of the biggest concerns of our members is the reduction in their social security benefits due to the Windfall Elimination Provision (WEP). This law, enacted during the tenure of President Reagan, reduces monthly social security benefits as a result of having a government or state pension, without paying into social security during said employment.

For years, we were hopeful that this provision, which affects nearly 1.7 million beneficiaries, would be repealed through legislation. A recent letter from Congressman William Posey to our member, Captain George W. Fisher, #2824 (*Ret*) provided an update to legislation introduced last year. Unfortunately, this legislation was not included in the recent Trump tax reform and there is very little optimism in the legislation.

Until some relief is provided, there is a way that a beneficiary may be eligible for a higher benefit. Based on an individual's work history and reaching the threshold of annual substantial earnings, the penalty can be reduced, substantially, as per Social Security Administration Publication #EN-05-10045. In fact, with 30 years of substantial earnings, the WEP becomes exempt. From 20 to 30 years, the penalty is reduced based on the percentage chart. visit: <a href="https://www.ssa.gov/pubs/EN-05-10045.pdf">https://www.ssa.gov/pubs/EN-05-10045.pdf</a>.

It is recommended that you either contact your social security office or go on line to determine your lifetime earnings subject to social security contributions. Apply that to the substantial earnings chart to determine how many years that you reached the annual threshold. If those years are between 20 and 30 years, your penalty is reduced according to the percentage chart.

You never know, give it a try!!!!!!!

### **CONCEALED CARRY INFO**

The status of what constitutes eligibility of concealed carry under Federal Law has been somewhat of a gray area when it comes to States Laws. The Federal Laws seem quite clear and certainly offer qualified law enforcement officers employed by or retired from local, State or Federal law enforcement agencies eligibility to concealed carry. Make no mistake about it, if you are going to concealed carry under the Federal Laws, **YOU** better know those laws inside and out. Do not, we repeat, **DO NOT** take the contents of this article as gospel that you can concealed carry under the Federal Laws, just because it is addressed in this publication.

A copy of an FOP Bulletin was forwarded for inclusion in this newsletter. ## New Medicare cards are on the way

May 18, 2017 by Andrew Johnson Consumer Education Specialist, FTC

Changes are coming to your Medicare card. By April 2019, your card will be replaced with one that no longer shows your Social Security number. Instead, your card will have a new Medicare Beneficiary Identifier (MBI) that will be used for billing and for checking your eligibility and claim status. And it will all happen automatically – you won't have to pay anyone or give anyone information, no matter what someone might tell you.

Having your Social Security number removed from your Medicare card helps fight medical identity theft and protect your medical and financial information. But even with these changes, scammers will still look for ways to take what doesn't belong to them. Here are some ways to avoid Medicare scams:

- Is someone calling, claiming to be from Medicare, and asking for your Social Security number or bank information? Hang up. That's a scam. First, Medicare won't call you. Second, Medicare will never ask for your Social Security number or bank information.
- Is someone asking you to pay for your new card? That's a scam. Your new Medicare card
  is free.
- Is someone threatening to cancel your benefits if you don't give up information or money? Also a scam. New Medicare cards will be mailed out to you automatically. There won't be any changes to your benefits.

# ASSOCIATION OF FORMER NEW JERSEY STATE TROOPERS EDUCATIONAL FUND SCHOLARSHIP PROGRAM

The Association of the Former New Jersey State Troopers Educational Fund, Inc. has been committed to provide educational scholarship opportunities and interest free loans to eligible State Police family members for several decades. The scholarship program will continue to offer scholarships to any child or grandchild of a New Jersey State Trooper (Active/Retired), who is living or deceased as set-forth in its By-Laws. The program consists of (3) annual scholarships being awarded, each in the amount of \$1,500.00. The scholarship is open to any student presently attending a college and maintaining a GPA of at least 2.5, and to any high school senior with an equivalent grade who plans to enroll in a state accredited college or university, anywhere in the USA. Selections are based on a lottery drawing, which shall include all applications submitted that meet the stated criteria.


