COLONEL'S COMMENTS



As we come to the end of 2021, the year that marked the 100th Anniversary for the New Jersey State Police, I wanted to take a few moments to offer just a few thoughts on this phenomenal Oufit of ours. This has been a special year for us. A year of remembrance of things distant in memory. A year of reflection on things gone wrong, and jobs well done. A year of tribute to those who lived and died as troopers, never forgetting to honor their service and sacrifice. We have upgraded the grounds around the State Police Museum and Learning Center to include the construction of a columbarium which will remain for ages in the shadow of our memorial garden which stands as a living tribute to those troopers who gave their last full measure of devotion. Those troopers were with us for such a short time and yet their influence is felt by all of us who followed them in the ranks and whose reputation is guarded and embellished by our actions.

Our major asset, as an organization, has always been our people, both civilian and enlisted. We continue to be blessed with dedicated women and men to carry on our tradition of service. A tradition rooted in Colonel Schwarzkopf's General Order #1 in which he stated, "the prevention of crime is more important than the punishment of criminals." The public and law enforcement agencies around our nation and world have recognized this high caliber of dedication and we should all be justifiably proud, yet humbled by, the many compliments and acknowledgments we receive. Think of that reputation for a moment. Think of our motto – Honor, Duty and Fidelity. To meet that self-imposed standard has not been an easy task. To gain that reputation, many members have spent decades building devotion to duty and integrity on that cornerstone.

Discipline through self-pride has always been the foundation of the State Police. Our first Superintendent, Colonel Schwarzkopf brought that concept from West Point and applied it to the first State Police Class in 1921. He made it a hard school for them, for he realized that those troopers were destined for a hard life. His methods proved to be right, and discipline and pride still set the State Police apart.

I ask each and every one of us to take a moment to think back to the early mounted troopers, crisscrossing the state on horseback and motorcycles, as they met the demands of bad weather, long hours and an often hostile

public. Today's young troopers meet those same demands in a more complex world populated by some who are violent and indifferent towards our mission. We have developed and implemented special equipment along the way such as in-car computers, cell phones, body worn cameras, forensic labs, helicopters, and the like, but it is still the trooper who makes our image. An image which holds Jersey Troopers a cut above the average and are not expected to need guidance at every step. Troopers that must show restraint when provoked, must be reasonable in unreasonable situations, must show dedication in the face of apathy, all while on public display. That takes a rare breed. Our troopers are a rare breed, individuals all, but all as one.

That is our strength. The strength that assures us that the State Police will continue in the next 100 years as before, and that Honor, Duty and Fidelity are not just empty words, but words infused with the life of those who took them as their standard from that first day they had the privilege to call themselves "Jersey Troopers." That standard, those words, our troopers, and our families all relate to those words and to that ideal. I would like to think that we are all better people because of that standard and that we will pass on that ideal to others, with pride. Pride – There's that word again. We are certainly a proud Outfit. We are proud of our women and men and their service over the past 100 years. I have no doubt that we will continue to be a proud Outfit and I want to let all of you know how proud, honored, and humbled I am to serve as your Colonel, but am even more proud to call myself a "Jersey Trooper."

May God continue to bless the New Jersey State Police as we enter into our next century of service to this great State and may God bless you and your families throughout the holidays. I also pray that 2022 comes with an abundance of health and peace for all of you and as always, stay safe out there.

2021 FORMER TROOPER OF THE YEAR

LIEUTENANT GEORGE J. WREN, JR., #3680 (RET)

In recognition of his dedicated 25 years of service to our Outfit, and 15+ years of service to the Former Troopers Association, the last 4 as Vice-President. George has always answered the call to serve; to the Outfit, to the FTA and to many who needed a helping hand. He had a remarkable career as a Trooper, serving in the Intelligence Bureau, doing undercover work, and rising to the rank of Lieutenant.

George's writing skills are outstanding which has been evident during his 11 years as the FTA's Newsletter Editor. He then researched, wrote and self-published Jersey Troopers II – The Next 35 Years (1971-2006). This is a highly acclaimed historical review of the State Police. These skills were heavily relied upon by the FTA to outline Mission Statements, Policies & Procedures, By-Laws, Permits, Trademarks, and correspondence that were all instrumental to bring the FTA into the 21st Century.

His FTA tenure has been high energy, endless accomplishments, including the Heritage Foundation's first Trustee Director, and for the past 4-years, serving as its Chairman as well as being an incorporator, Director, and the 1st Corporate Secretary of True Blue and Gold, Inc. He reformed our website accessed by thousands. During the NJSP's 100th Anniversary Year of 2021, he assisted at every event including the FTA & NTC Picnics, and Former Troopers Night Centennial Cocktail Party, as well as endless other FTA responsibilities.

In the midst of COVID 19 and preparing to be the next FTA President, George took on the responsibility to oversee construction of the Columbarium, a successful project that is nothing short of miraculous. Trooper I William T. Trump, #2516 (Ret) was recognized at the Fall General Membership Meeting for his quick, decisive actions in assisting a neighbor during a stressful choking event. Things certainly do happen in the blink of an eye, often without warning!

During the late morning of October 29, 2021, Bill and his wife Joan were inside their Naples, Florida home when suddenly their next-door neighbor burst in screaming, “Steve is choking to death in our kitchen.” Without hesitation, Bill ran to the women and they both rushed to the neighbor’s home while Joan immediately called 911. Upon entering his neighbor’s home, Bill found Steve bent over the kitchen sink gasping for air. A quick assessment led Bill to immediately realize that Steve was in despair. At 6’-3” and 260 lbs., Steve was a lot to handle, but Bill was able to pull him upright and began administering the Heimlich Maneuver.

Bill’s first thrust didn’t work, and Steve began to start falling towards the sink. Maintaining control of the exhausted man, Bill administered as second, and then a third thrust, but again no results. Bill could see that Steve was fading fast and slumping forward. Thankfully, Bill’s fourth thrust did the trick and dislodged the cause of the emergency and out popped pieces of the culprit, a carrot. A few deep breaths, and Steve was able to regain his composure, stand on his own and speak to Bill about his status.

About ten minutes later a Deputy from the Collier Co. Sheriff’s Department arrived, followed shortly thereafter by Paramedics who checked Steve out and advised he was fine thanks to the quick actions of his neighbors.

Instances such as these happen when they are least expected. Thanks to his first aid training and quick response, Bill Trump was able to step-up and handle a life-threatening situation through to a successful outcome.

MEMORIAL COURTYARD RENOVATION AND COLUMBARIUM PROJECT



The past two issues of True Blue & Gold have offered updates on the progress of our Memorial Columbarium and Courtyard Renovation Project. While many may think that this endeavor was just launched in the last year, it all began almost a decade ago when structure failures and courtyard flooding started being noticed in the Memorial Garden and surrounding courtyard. The FTA hired engineering and testing firms to inspect and analyze the problems, and over time it was determined that the Memorial Garden and Courtyard would have to be replaced. Several concepts were offered, but none seemed to reflect the significance or expanse of this very important site.

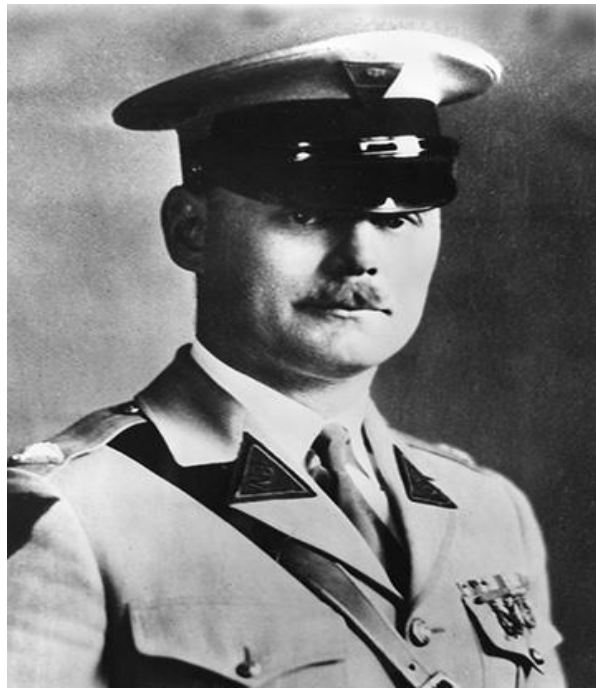
Realizing the magnitude of respecting this hallowed ground and developing it into being a focal point of the Division Headquarters Complex, FTA President, Captain Nicholas C. Sorzano, Jr., #3065 (*Ret*) and Heritage Foundation Chairman, Lt. George J. Wren, Jr., #3680 (*Ret*) undertook a plan to create a consortium of investors, contractors and materials suppliers that would solidify that objective. With Nick handling fundraising, purchasing, and scheduling, and George handling the design, planning and construction supervision, they quietly broke ground in late April with Colonel Patrick J. Callahan, #5243's blessing, and they have been at it ever since.

The original project focused on a partial replacement of the Memorial Garden and renovation of the surrounding courtyard, with planned expansions for the future. But George and Nick had a different vision, "We either go big, or we go home!" As the project got underway that focus grew to include additional, larger columbarium units that now have the capacity to respectfully and honorably house the ashes of some 2,640 individuals, Jersey Troopers, and their Spouses! A grand entrance walkway was created to access the now approximate 8,000 square foot Memorial Courtyard, an underground drainage system was installed, not to mention the many utility relocations. Granite recycled from the Memorial Garden was also made a prominent part of the project, accented by stonework, and extensive courtyard lighting. Belgian Block curbing was added, street reconfiguration and repaving, not to mention an extensive landscape that now proudly enriches the look of the property.

This project is by far the largest undertaking ever entered into by our FTA and Heritage Foundation! Estimated at over \$1.5 million, 90 % of the materials and professional craftsmen were graciously donated by New Jersey area suppliers, contractors, and craftsmen. This was truly a phenomenal undertaking by all concerned, unparalleled in generosity and pride, just to be a part of such a worthy venture. While much of the work was performed by skilled tradesmen, day to day work was handled by George and Karl Meier, the Owner/Operator of Meier Stone in Flanders, NJ. A truly generous gentleman, Karl graciously donated his time, expertise, and a good bit of materials to get the job done! In a pinch, about dozen retired and active Jersey Troopers also stepped-up to help-out when the need arose. Thank you all very much! Our next issue of True Blue & Gold will include an overview of the many materials suppliers, contractors, tradesmen, and donors that made this undertaking a reality that will last forever! Hopefully, a dedication of the Memorial Columbarium will take place before our next newsletter so we can give a full accounting of the many accolades that are certainly due.

As of this writing, the finishing touches and landscaping are being completed. Arrangements are being made to facilitate the administration and perpetual care of the new Memorial Columbarium and Courtyard by our Heritage Foundation. Once everything has been ironed out, we will publish the policies and procedure for reserving a prestigious final resting place should any Jersey Trooper and their Spouse be interested. RECALL AND REVERE



Colonel H. Norman Schwarzkopf

In the early years of the last century, New Jersey was making a limited effort to provide protection for its rural inhabitants. This effort was wholly dependent upon the county sheriff and his constables. Based on a political system of election and appointment, there were varying degrees of success. Demands for a uniformly well-trained rural police force increased in direct proportion to an increasing population and crime rates.

Legislation for this purpose was first introduced in 1914 and for several years thereafter. However, at the time, the State Police movement had become general throughout the country with thirteen states having already organized such a force. The State Chamber of Commerce and the New Jersey Grange continued their efforts on behalf of the legislation.

Finally, on March 29, 1921, the State Police Bill was passed into law. Senator Clarence I. Case, who introduced the bill, is known as the "Father of the State Police." On July 1, 1921, Herbert Norman Schwarzkopf, a graduate of the United States Military Academy at West Point, was appointed as the first Superintendent of the State Police by Governor Edward I. Edwards. Schwarzkopf was commissioned to organize the first training class. Competitive examinations were held for the purpose of selecting the type of man desired for this service.

Sixteen hundred men, between the ages of twenty-two and forty, made application for the one hundred and twenty positions. Only two hundred and twenty-seven received a passing mark. From this number, one hundred and sixteen men reported to Sea Girt on September 1, 1921. Eighty-one officers

and troopers completed the rigorous three-month training program. On December 1, 1921, the new troopers were administered the oath of office and on December 5, 1921, in a blinding snowstorm, started out on horseback and motorcycle to their posts throughout the state.

Colonel Schwarzkopf's military background greatly influenced all areas of the newly formed organization. During training olive-drab denims, courtesy of the Army surplus store, served their purpose very well. As the end of training approached, the need for a distinctive uniform became a priority. Schwarzkopf outfitted the new troopers in what was standard from 1921-1924. That original uniform consisted of a Stetson hat, brown boots, olive britches, gray shirt, Jersey blue tie, navy wool blouse and Sam Browne belt and holster. The belt forced the wearer to "brace" like a West Pointer, which was exactly why it was chosen by Schwarzkopf.



When the State Police began operation in 1921, the force of new troopers was divided into two troops. Troop A was headquartered at the Raleigh Hotel in Hammonton and covered South Jersey. Troop B was headquartered at the Imperial Hotel in Netcong and covered North Jersey with five substations. A platoon headquarters was established in Freehold with three substations. This was the forerunner of a third troop, Troop C, which was established in 1928 to patrol Central Jersey. The first modes of transportation consisted of sixty-one horses, twenty motorcycles, one car, and one truck. The horse remained the principal means of transportation throughout the twenties.

The success of the New Jersey State Police may well be attributed to the theories adopted by Colonel Schwarzkopf who believed that the agency was not only an enforcement and apprehending agency, but that prevention, education, and service are equally important for the success of the mission of the organization. Furthermore, it is believed that the training and duty of the members of the State Police should be made such that it develops character, reliability and troopers who enforce the law.

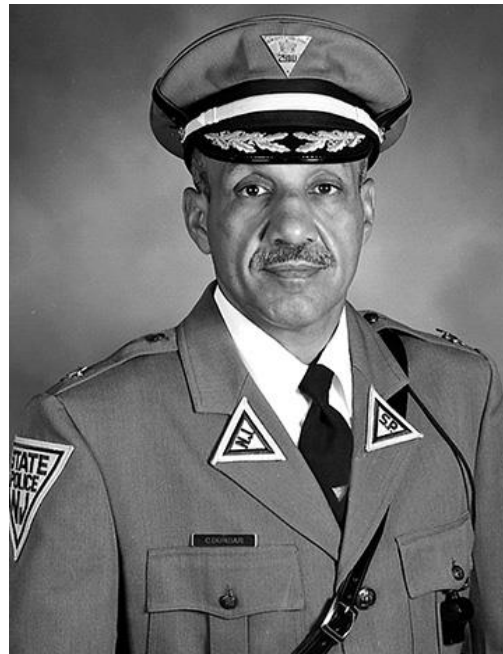

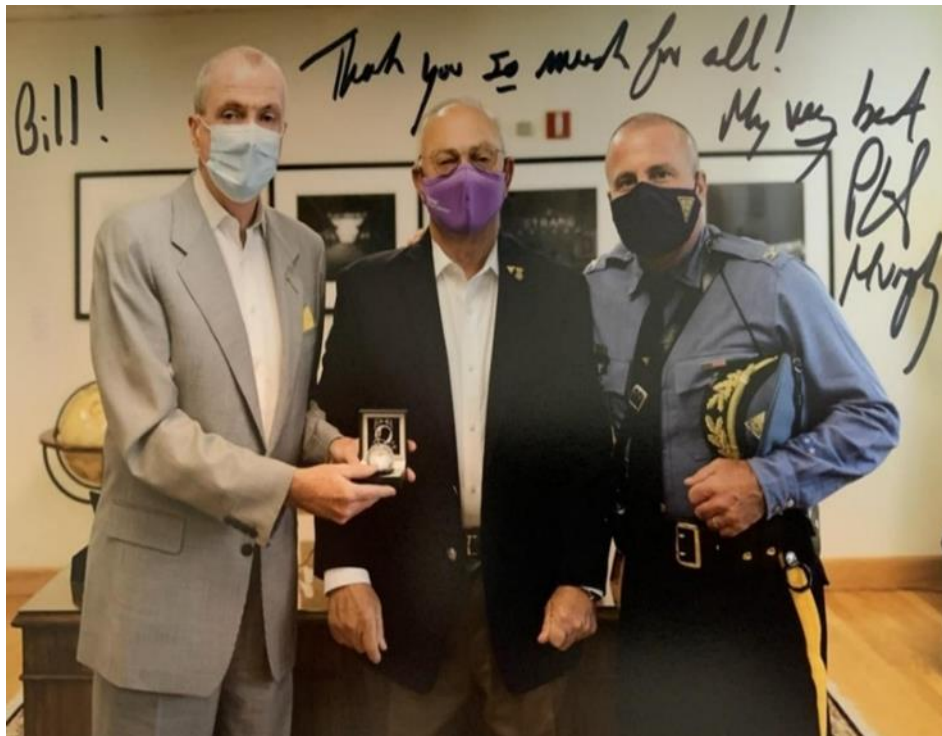

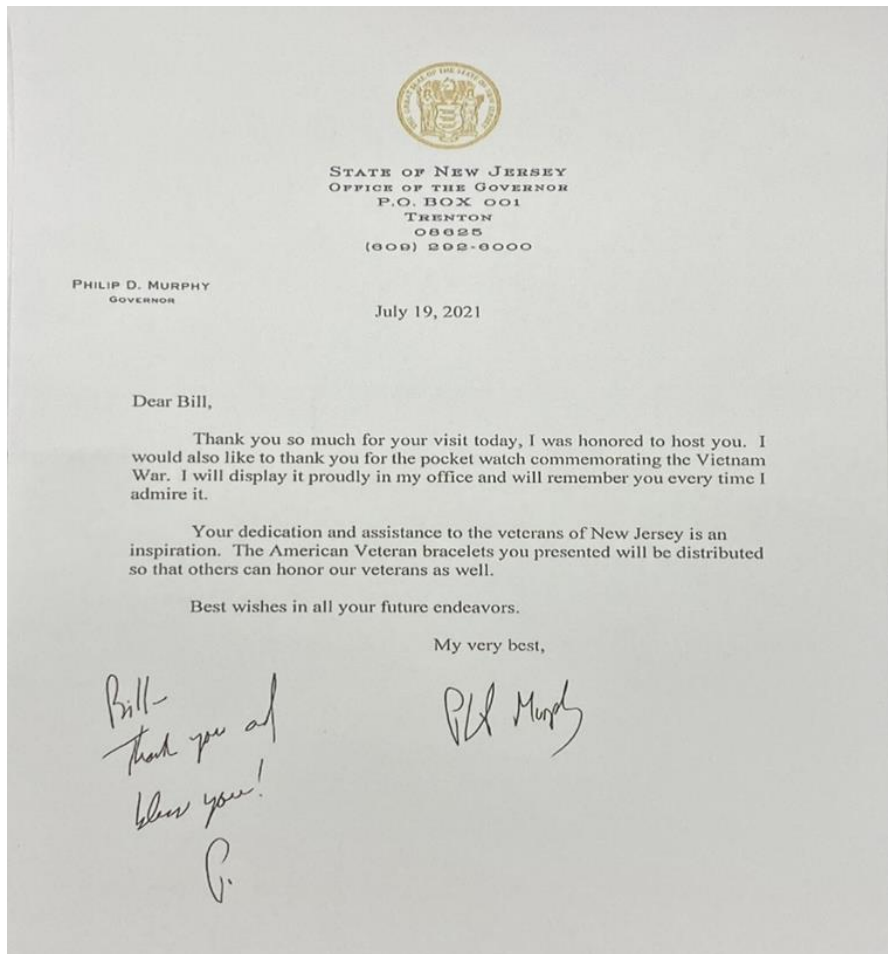
TROOP "A" OLD-TIMERS GET-TOGETHERS

NEW this year, once a retiree OR spouse turns 65 and enrolls in Medicare, the retiree and/or spouse moves over to the Aetna Medicare Advantage plan. Retiree or Spouse and eligible dependents who have NOT yet turned 65 will be enrolled in a non-Medicare advantage Aetna plan. Please see below taken from NJ Pension and Benefits website:

Aetna Medicare Advantage Plans

Medicare Advantage plans, sometimes referred to as "Part C" or "MA plans," provide Medicare Part A (inpatient hospital insurance) and Medicare Part B (outpatient medical insurance) coverage. The Aetna MA plans offer access to providers nationwide, with the same benefits in or out of network, and no referrals required.

SHBP Medicare-eligible retirees can enroll in the following Aetna Medicare Advantage plans: Aetna Medicare Advantage PPO ESA 10;* Aetna Medicare Advantage PPO ESA 15; Aetna Medicare Advantage HMO and Aetna Medicare Advantage HMO 1525.

**Not all State retirees will be eligible for Aetna Medicare Advantage PPO ESA 10*

Spouse or Partner with Different Medicare Eligibility than the Member

Medicare-eligible retirees enrolled in a non-Medicare Advantage plan and who have a spouse or partner who is not Medicare eligible will move to the Aetna MA plan while the spouse/partner and/or any covered children remain in the non-Medicare-Advantage plan. Similarly, retirees who are not eligible for Medicare but have a spouse or partner who is Medicare eligible will remain in their non-Medicare-Advantage plan (along with any covered children) while the spouse/partner is transferred to the Aetna MA plan.

PREVIOUSLY, when the retiree or spouse turned 65 and enrolled in Medicare, they were moved over to a Medicare Advantage health plan while the non-Medicare spouse and eligible dependents remained in their current health plan, they will now be moved over to the NON-MEDICARE Aetna plan.

Please be sure to enroll in Medicare upon turning 65. It is recommended that this be done approximately 2 months prior to turning 65. Proof of enrollment needs to be sent to Pension and Benefits. This needs to be done for both the retiree and spouse prior to turning 65. It is recommended that you visit your local Social Security office or enroll online. Fact sheet 23 addresses Medicare Enrollment, it can be found here:

For those retirees who must pay additional Medicare premiums due to higher income limits, please check the link listed further up and click on Letters to Retirees for information on having those additional premiums reimbursed. There is a due date established each year for reimbursement, if you miss the deadline date, you will not be reimbursed for the prior year's additional premiums paid. Upon turning 65 and enrolling in Medicare, Medicare becomes your PRIMARY insurance and the State Health Benefits – Aetna Medicare Advantage plan becomes your SECONDARY insurance. The majority of the time, you will need to only present your Aetna Medicare Advantage Plan membership card to the medical professional you are seeing. Your medical professional will submit billing to Aetna Medicare Advantage, who will coordinate processing of the claim with Medicare.

Change of Address and/or Financial Institution Changes

Please be sure to notify Pension and Benefits of any changes to your address and/or banking information. Any of these changes need to be reported immediately as to not affect the depositing of your monthly pension check, or receiving important benefit information by mail. Again, you can make these changes online through your MBOS account, but either way, please be sure they have your current address and banking information. Pensions and Benefits is the only one who has access to your account information. As I am not an employee of State of NJ, I do not have access to a retiree's personal information.

REPORTING A DEATH

Pensions and Benefits should be contacted as soon as possible regarding the death of a retiree OR spouse. Please contact them at 609-292-7524. It is recommended that this telephone number be written down and kept with your important papers so it is readily available when needed. The sooner they are contacted, the sooner any survivor benefits and insurance benefits can be completed. After contacting Pensions and Benefits, please reach out to Patti at the FTA office to notify the FTA office of any changes at 609-882-2000, EXT 2220.

Surviving Spouses of Retirees Tax Implications:

After the passing of a retiree or spouse, the surviving spouse will need to have the income tax adjusted for the pension. The default is set to 2 deductions and will need to be changed to "1" to offset any end of year tax "surprises." This can be done online through your MBOS account.

A **LIFE INSURANCE BENEFIT** is available to eligible retirees through the State of NJ. This life insurance benefit is provided through Prudential and the benefit is equal to 50% of the final year of salary of the retiree. This benefit is payable to your listed beneficiary. Beneficiary info can be accessed through your MBOS account, and if it needs to be changed, you can do it right online. If you do not have an MBOS account the form can be accessed through the first link listed above.

If you do not have computer access, you will need to contact Pensions and Benefits at 609-292-7524 and have them send you a form to change.

State Police and Brigantine Police Solve 25-Year-Old Cold Case

DNA Evidence to Arrest Suspect for Sexual Assault of 10-year-old Girl

Brigantine, N.J. - The New Jersey State Police and Brigantine Police Department have charged Brian Lee Avis, 59, of Egg Harbor City, N.J., for the sexual assault of a 10-year-old girl during a 1996 home invasion, after detectives used DNA evidence to solve the 25-year-old cold case.

On July 19, 1996, the Brigantine Police Department responded to the report of a sexual assault at a local residence. A male suspect allegedly broke into the residence in the middle of the night and sexually assaulted a 10-year-old girl while she was sleeping.

Detectives collected evidence at the scene and obtained a DNA sample of the suspect from the victim's bed. The suspect's DNA profile had been generated in 2002 and was uploaded into the Combined DNA

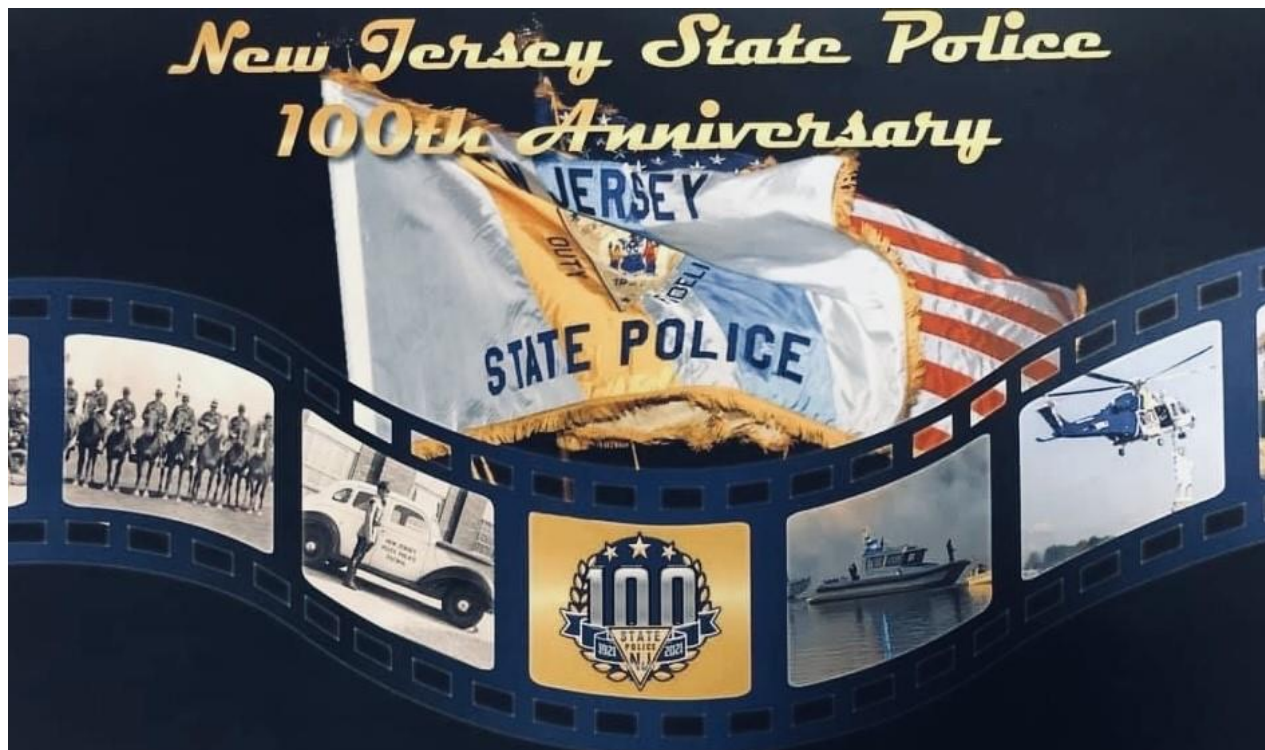
Index System (CODIS), which is a national DNA collection database, however there were no CODIS matches for the profile.

During the summers of 1995 and 1996, there were approximately 14 reported incidents of an individual engaging in voyeuristic behavior and attempted sexual assaults of two sleeping teenage girls in the Brigantine area. Investigators determined that the suspect lived in the vicinity, but he was never identified, and the cases remained unsolved.

In January of 2021, detectives from the New Jersey State Police Cold Case Unit and Brigantine Police Department reopened the case in a cooperative investigation. Detectives began working with the New Jersey State Police Office of Forensic Sciences (OFS) and a private company specializing in Investigative Genetic Genealogy (IGG). The evidence was resubmitted to OFS and a more robust DNA sample for the suspect was obtained. On July 26, 2021, detectives submitted the DNA to a private laboratory for analysis.

On September 12, detectives located Avis and executed a search warrant for his DNA. The sample was a positive match to the DNA obtained at the scene. On September 13, Avis was arrested for the aggravated sexual assault and lodged in Atlantic County Jail.

“The sanctity and security of a 10-year-old girl’s bedroom was violated by a heinous act committed 25 years ago, violently stripping her of her innocence resulting in emotional scars that are as fresh today as they were that fateful summer night in 1996,” said Colonel Patrick J. Callahan. “I commend our Cold Case Unit detectives and members of the Brigantine Police Department for reopening this case and working collaboratively by using modern technology to bring justice and closure for the victim.”

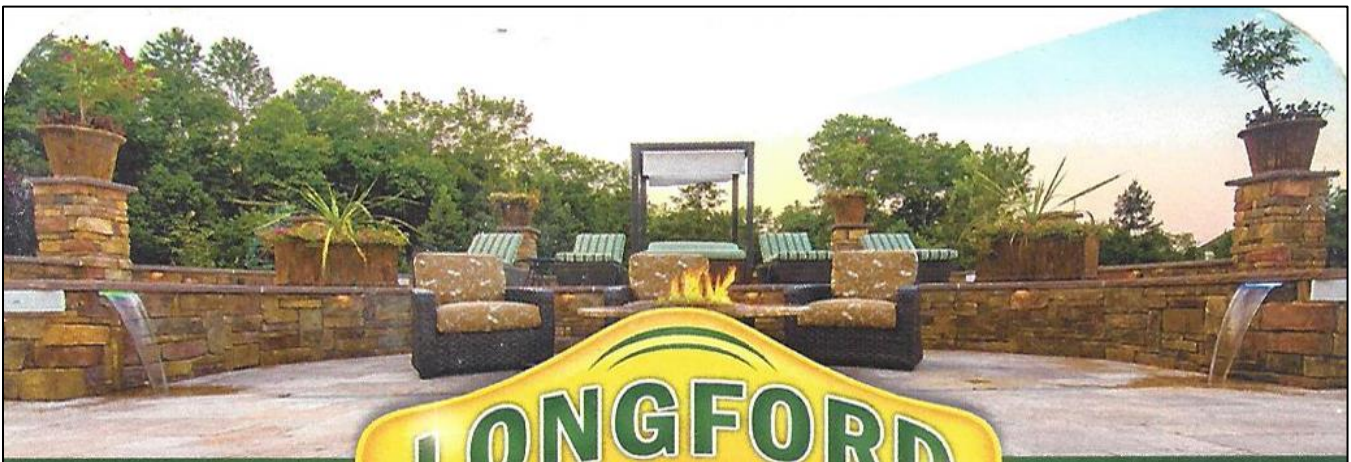
